Thank you for your email of 3 July 2019 to the Ministry of Education requesting the following information:

- 1. Any and all communications and documents pertaining to Samuel Marsden Collegiate School's endeavours to turn their Whitby campus into a state-integrated school.
- 2. Any and all communications and documents pertaining to Samuel Marsden Collegiate School's endeavours to turn their Karori campus into a state-integrated school.
- 3. Any documents filed with the Ministry regarding the proposed closure of Samuel Marsden Collegiate School's Whitby campus.

Your request has been considered under the Official Information Act 1982 (the Act).

At the time of your request we had not received any communications or documents relating to applications from Samuel Marsden Collegiate School to turn the Whitby campus into a state-integrated school. Therefore, I am refusing parts one and two of your request under section 18(e) of the Act, as the documents alleged to contain the information requested does not exist.

I am providing you with 19 emails relating to the Samuel Marsden Whitby's decision to close. My decisions on the release of these emails are outlined in the document table attached as **Appendix A**.

I do not consider the public interest considerations favouring the release of this information are sufficient to outweigh the need to withhold it at this time.

It is with sadness that I am officially notifying you that the Samuel Marsden Collegiate School Trust Board has made the difficult decision to close Samuel Marsden Collegiate School Whitby at the end of the 2019 school year.

The last day of school will be Friday 6 December 2019 for students and Tuesday 10 December for staff.

As at today's date we have 75 girls and 95 boys attending Marsden School in Whitby.

The future of the school was looked at very carefully, with options explored to keep it open, however it is not financially viable to keep it open beyond this year.

This is an extremely difficult time for our Whitby School community. We are focused on supporting our students, families and staff and we are helping students and their families with their schooling choices and transitioning for next year.

We notified our Whitby community of this on 1 July, including staff, parents, students and the ISEA.

This decision has **no** impact on Samuel Marsden Collegiate School in Karori. All girls at Whitby have been given the option to transfer to Karori. The boys will be assisted with their schooling choices and transitioning for next year.

Schooling at Whitby will continue as normal until the end of the 2019 school year, up to and including 6 December 2019.

The positions of all Marsden Whitby staff members will be disestablished on 10 December 2019. We will be consulting with staff around potential redeployment opportunities. In the event that we are unable to provide suitable redeployment, staff will be made redundant on 10 December 2019 and they will receive redundancy payments and their other contractual entitlements.



Just letting you know what we are doing:

Kayne is looking at the dot map so we can see where the students live and which schools they may potentially enrol — he will work with you Philippa and Vincent on this. Many of our public schools in that area have big numbers and there are not really any private options for boys other than Scots

Ministry staff have contacted local colleges this morning (8am – 9am) – Kapiti College, Aotea College, and Tawa College to keep in contact re possible enrolments. Some interest has already been shown at Aotea and Kapiti.

#### Options for students for next year.

Samuel Marsden are offering all girls the option to attend Samuel Marsden (Karori Campus). This will be offered at the same fee level as for Whitby. They will also be offering assistance with transport.

The school will do whatever it can to support the boys to enrol in other schools. They are currently contacting local Colleges, St Pats Silverstream and Scots College.

#### Keen to have a further discussion re where students may go.

We offered to visit and discuss progress with student placement. The school did not pick up on the offer at this time but may contact us next term.

#### Any support that may be needed for staff as they work with students.

All staff are okay at this stage. Additional counsellors are on site to work with any staff and students who need support.

#### Do you have any thoughts as to what you may do with the property?

At this time there are no plans as to what may be done with the property. When this is being thought through the school will contact the ministry to discuss possibilities.

#### **Extract from Samuel Marsden website.**

The Samuel Marsden Collegiate School Trust Board has made the difficult and sad decision to close Marsden School Whitby at the end of the 2019 school year. This decision has no impact on Marsden School in Karori, which has been delivering quality education for girls for the past 141 years.

Principal Narelle Umbers advised the school community of the decision on 1 July and says it is with deep regret the Board has reached the conclusion that it is not financially sustainable to continue to run Marsden Whitby beyond this year.

The future of the school has been looked at carefully. The difficult decision to close was only made after the Board explored options to keep the school open. The focus is now on supporting the school community and assisting their transition to new schools. Marsden Whitby staff are committed to continuing to provide Whitby students with a quality education through to the end of the school year. This is an extremely difficult time for our school community and we are supporting and working with students and their families to help them with their school choices for next year.

Marsden Whitby has accomplished much over the past 15 years and the staff, students and families have built a special community spirit at the school. The staff have delivered a quality education and students have excelled academically and outside of the classroom. Many close relationships have been formed, and over the next six months we want to involve our students, staff, families and alumni in how we recognise all the school has achieved.

The decision has no impact on Marsden School in Karori. We will continue to have a strong focus on ensuring girls flourish at Marsden in Karori. The School has recently become New Zealand's first Visible WellbeingTM School. All Whitby girls will be offered a place at Marsden in Karori and the boys will be assisted in finding a school to continue their education.

No doubt you've been made aware that it was announced that the Samuel Marsden Whitby secondary school (private) is to close. The community is smarting by this announcement which came out of the blue by all accounts and is reflective of a poor change process.

We live in Whitby and it is significantly growing as is the wider region. I wondered if your group might look into the feasibility of purchasing the site before the retirement village does. The MOE site nearest us doesn't have a primary school built on it yet and I wondered if this may be something worth investigating as an alternative.

Our eldest is just about to enter into primary school which is not walking distance due to the zoning -Pauatahanui School is closer to much of the new developments in Whitby - and the ECE are chocka in the Northern Ward due to young families. Ideally, we would have a secondary school that doesn't require a drive/bus/train and this site could also potentially serve that age range but I expect practically it might be easier to be a primary school.

Do you think the Ministry could investigate the feasibility? I understand it's budget time so it may/not be a good time but given the interest that is likely to ensue, time will be of the essence. I'm not sure where you live s erai a beyond

S erai but Porirua is really large and it takes a good 20 min drive to get to Aotea College and certainly parents don't want to travel all the way over to Porirua CBD area for other alternative high schools beyond Aotea.

Here's some lines we used around Tuturumuri that might be a starter for the answer to the closure process for state schools

Closing schools is never an easy decision and is only made after extensive consultation with the local community.

There is a legal process which must be followed when a school is being considered for possible closure. This includes the Board undertaking consultation with the community and the Ministry consulting with the Boards of schools whose roll may be affected. This includes Martinborough School, Pirinoa School, and Kahutara School. We envisage that this process will take around 6 weeks.

Would it be possible to have a guide to a possible response/bullets by 2.30?
