



Thank you for your email of 31 October 2017 to the Ministry of Education requesting the following information under the Official Information Act 1982 (the Act):

- *"I would like to request all written communication, including emails and meeting minutes, and notes, between the Ministry of Education and Victoria University of Wellington that includes but is not limited to the sale of the Karori Campus, the Ministry's negotiations and offers to buy land at the site, and the proposal of a technology hub, dating back to September 2016."*

On 9 November 2016, we contacted you advising you identifying all emails for this period may not be possible. Your request was then refined to:

- *"All correspondence, meeting minutes, and notes between the Ministry of Education and Victoria University of Wellington regarding the sale of Karori Campus and development of a technology hub since December 2016."*

We have included an overview of the various property transfers, negotiations and decisions surrounding Victoria University of Wellington (VUW) below.

Transfer of Crown assets to Victoria University of Wellington

The Crown Asset Transfer and Disposal Policy for Crown-owned assets managed by Tertiary Education Institutions (TEIs) was established by Cabinet in March 2010. The policy allows TEIs to obtain legal ownership of Crown assets that are core to their educational purposes and to dispose of those which are surplus to requirements.

The intention of the policy is to provide a clear framework for ownership and control of Crown title assets and to encourage TEIs to manage these assets in an efficient manner.

In September 2010, Victoria University Wellington (VUW) applied to the Tertiary Education Commission for transfer of Crown assets under its management at the Karori campus site.

VUW agreed a memorandum of understanding for the transfer process with the Secretary for Education in April 2012. The transfer was then completed over three tranches, from December 2014 to December 2015. Each of the three transfer tranches were documented in agreements under Section 50 of the Public Works Act 1981 (PWA), with a nominal consideration of \$10 paid by VUW per tranche.

The Sale and Purchase of Real Estate agreement covering the campus was signed on 16 March 2015. The Gazette Notice was then issued on 2 April 2015 and the Land Transfer Register was updated on 8 April 2015.

Disposal of surplus assets

On 30 August 2016, VUW notified the Ministry of its decision to declare the Karori campus surplus to requirements with immediate effect. The Ministry met with VUW to discuss the request, and raised its interest in some of the campus land including the sites occupied by Karori Kids and Campbell Kindergarten (the ECEs).

On 2 December 2016, the Secretary for Education granted consent for VUW to dispose of its Karori campus properties. This was subject to VUW's compliance with PWA requirements and the conditions specified as part of the initial transfer to VUW ownership.

VUW was also advised the Ministry was reviewing its educational capacity needs for the area, and it did not expect to be able to confirm its PWA requirements until early 2017.

Campbell Kindergarten and Karori Kids

Discussion between the Ministry and VUW has been ongoing from early 2017. Our first focus was ensuring the ECEs remain on their current sites.

Given the nominal sum paid by VUW to gain ownership of these sites, the Ministry considered transferring the sites back to Ministry ownership should also be at nominal cost. Negotiations over the transfer value progressed through to July 2017, when the Ministry agreed to compromise on the amount to be paid to VUW.

The sale and purchase agreement for the ECE sites was finalised in August 2017, at a value of \$931,500. The Ministry will become the future landlord of the ECEs and they will continue to operate as they currently do.

Main Karori Campus site

The Ministry also explored the educational requirement for the main campus site. Options including providing additional land for surrounding schools and a potential technology hub were considered and we began negotiations with VUW on a parcel on land.

Negotiations between the Ministry and VUW have now concluded and unfortunately our offer was substantially less than some of the other offers received through the open market sale process VUW initiated on 7 August 2017.

We are satisfied that Public Works Act 1981 requirements have been met and have advised Land Information New Zealand (LINZ) accordingly.

We know that this decision will be disappointing for some in the Karori community but we have worked hard to secure the land for a technology hub and are obliged to consider value for money for the taxpayer. As we stated in March 2017, we could only buy the land if we could get it at the right price.

We will now investigate other options to meet technology provision for Wellington schools.

We have identified **110** documents in scope of your request. A table summarising our decision on their release is attached as **Appendix A**.

Please note, we have done our best to identify all emails between Ministry staff and VUW for the time period you have requested. Due to the complex nature of the various negotiations and processes related to the Karori Campus, a large number of staff across the Ministry have been involved. Our search has primarily focused on staff from Tier 3 and above, unless responsibilities on a particular issue were delegated to a specific staff member from Tier 4 and below.

Please note, the Ministry now proactively publishes OIA responses on our website. As such we may publish this response on our website after five working days. Your name and contact details will be removed.
