Thank you for writing to the Ministry of Education on 9 November 2019, to request communications between the Ministry and Tuturumuri School, including its Board of Trustees, since September 2018.

Your request has been considered under the Official Information Act 1982 (the Act).

Your email also requested the Ministry provide an opinion on matters to do with the ownership of the school residence, and matters to do with the current consultation, which I am advised were responded to separately by the Office of the Director of Education for Wellington on 21 November 2019.

We recognise that members of the Tuturumuri and Tora communities have put considerable effort into supporting the school to increase its roll over the last two years, but this did not result in a sustained increase in enrolments.

In Term 3, 2019, the Board of Trustees of Tuturumuri School held two community meetings to discuss the future of the school. However, no unanimous decision could be reached. The school then contacted us in September to say that while they had two students currently enrolled, there was potential the school would have no students in term 1, 2020 and asked us to make the final decision.

The decision to close a school is never an easy one, but on 5 November, we agreed to undertake consultation on the potential closure of Tuturumuri School.

This consultation is with the Board of Trustees of Tuturumuri School and neighbouring schools whose roll might be impacted by the potential closure. The Principal's email to the community is part of this consultation process as the Board considers the future of the school.

If there are students at the school and it closes, we will provide support to parents should they need help getting their children into new schools

Your request

A list of 38 documents within scope of the request, and my decisions regarding their release are attached to this report as **Appendix A**. I have withheld information from the documents under section 9(2)(a) of the Act, to protect the privacy of natural persons. Some information not within scope of the request has also been redacted.

I have not found any countervailing public interest consistent with section 9(1) of the Act which overrides my decision to withhold this information.



We are not able to give a timeframe at this point for the removal of the LSM so you will need to provide for this in your budget next year. The Ministry will need to be assured that the board is carrying out its role competently before it considers removal of the LSM. I spoke to the LSM about accessing training from NZSTA now that you have elected the new trustees to ensure that the board is both informed and supported. NZSTA are supporting the board.

Hi Alistair

I also used the website to make sense of the banking staffing. If you are to use the 26 days from banking staffing you will get the fulltime teaching equivalent (FTTE) rate of \$72,500.00. However if you chose not to use it the reimbursement in the ops grant will be at the lesser rate of \$55,500.00. The reimbursement rate is \$17,000.00 lower which effectively ensures you use the allocated staffing As a teaching principal, think about using the banked staffing to support your release to get all beginning of the year jobs sorted i.e. Annual plan, budgets

I have copied the relevant part from the website below: Reimbursement - Underused

If your school remains in an underuse position at the end of the balancing period the underused staffing is paid to you in the July instalment of your operational funding. Boards in receipt of special reasons staffing will have the balance of any underused staffing offset by the special reasons staffing before any reimbursement is made.

The banking staffing rates are used to calculate the dollar value of your banking staffing balance at the end of the year. The recovery rate applies to staffing usage that exceeds staffing entitlement. The reimbursement rate applies to staffing usage that is less than staffing entitlement.

We have currently begun board succession planning, as per NZSTA's guidelines, and have adopted their proposed timeline for elections. Furthermore, each board member has agreed to begin working through their training modules, and have already begun making progress, with emphasis given to areas of current need (for example, we all completed the module on Charter and Analysis of Variance for last meeting).

From my one meeting with the Board, I am happy that they are all willing to contribute and continue to upskill themselves in order to meet the need of the school and the students.

I should also note here that we have begun discussing the development of a school vision, charter and curriculum, involving a series of community huis, consultation with the local hapu (who, on a side note, have very kindly offered to come in and chat with the children about the regions history!), in order to bring it up to date with the current community and school.

(2) Staffing

Principal Appraisals, we have been engaged in discussion with Kevin Palmer, Education Consultant, to run the appraisals. I have a phone meeting with him later today, and am meeting in person this weekend. He was recommended to me by another local principal, and talking to Kerstin he had actually provided a quote for the principal's appraisals in the past, so the board is fine with that. Laura Snowden was originally approached, but she was too busy to run another appraisal.

I have talked with the Education Council regarding Renita (and spoken with Renita, of course). Her current teaching status is Subject to Confirmation. The Education Council assures me that this is exactly the same as a Full Registration, but means that she cannot conduct appraisals of other staff nor mentor new teachers. Unlike Provisional Status, the Subject to Confirmation can be renewed indefinitely. To qualify for Full Registration, she must undergo a mentoring programme for 12 months, with 0.5 teaching. With this in mind, both Renita, the Education Council and myself are alright with things as they are and she is able to continue renewing her registration indefinitely.

However, with that note, it does pay to note that we may be able to increase her hours this year. Due to banked staffing, she has been working 0.6 this term, and I am entitled to apply for another 10 days release time funded through the Ministry (new principals in U1 and U2 schools), which will cover Term 2 and Term 3 - this leave just five days, which the board has discussed funding.

Hope that provides the answers to your questions. If there's any more, I'm more than happy to help!

Morning Lynette,

Very positive ERO experience. They were quite taken with what we have here and understanding of where we have come from. They mentioned a number of times that it seems obvious that we have clearly identified good priorities for revising the school and we had numerous detailed talks about trying to craft the language in their initial findings to show that (a) we have had a rough year (2018); and (b) we are on a good track and are aware of what still needs to be done.

Notes I took from their initial findings - bullet points scribbled down on my phone, I'm afraid:

- Due to low fluctuating roll, it's difficult to identity how well the school is achieving and sustaining
 equitable and excellent outcomes for students over time.
- Individualised teaching in 2019 has successfully promoted equitable and improved outcomes for each student in mathematics and literacy.
- School has been successful in accelerating the learning of all students.
- "A well considered approach is now in place for managing school development and operation. Trustees have shown significant commitment to securing community support and achieving the permanent appointment of a teaching principal. Together the principal and trustees have identified priorities for development."
- New operational guidelines in place. External support has been accessed to support the revision and documenting of schools long term planning and local curriculum - this is likely to lead to sustainable approach to managing the school.
- Good focus on building leadership and teaching capabilities, including strong involvement with the kahui ako.
- Student wellbeing is priorities
- · Specialised assistance is in place for any child needing support.
- "Board and principal have identified, and EROs evaluation concurs," that key priorities for the school includes:
 - o continuing to secure community/iwi relationships,
 - o working with community to revise school direction,
 - o strengthening stewardship
 - o strengthening of internal evaluation process



Dear Louise

As you know, the Minister of Education has agreed to us consulting with your Board on his behalf, and the boards of neighbouring schools about the possible closure of Tuturumuri School.

This is a Ministry initiated possible closure process, with two stages. The first stage allows other boards to consider the possible closure and provide feedback to us, as well as providing your Board a chance to do the same. We are proposing that the consultation period runs for four weeks, starting today on 7 November 2019 and ending on 5 December 2019. We believe that four weeks is an appropriate time period given the consultation that occurred with your community and neighbouring boards in 2018, as well as the recent consultation that your Board undertook with your community during Term 3, 2019.

Following the first consultation period, we will consider the feedback received, and then prepare a further education report to the Minister of Education for his consideration and a decision on next steps. If the Minister agreed to progress the closure, we would enter into the second stage of consultation. The process at that point would be to provide your Board with a further 28 days to provide any further reasons why the school should not close. We would then consider the arguments put forward, and prepare a report to the Minster seeking a final decision on whether or not the school should close.

We are aware that this is the second time we are revisiting the possible closure of your school since 2017, and that there has already been extensive consultation as a result of this. Your Board may feel there is nothing further to discuss and may not wish to provide feedback as part of this consultation process. Your Board also has the option to agree, at any time, that the school should close. If this is the case, please us know and we can advise the next steps.



We are aware that this is a difficult time so please let us know if we can provide any additional support. As part of this process, Alana McCorry, Lead Advisor Network is happy to meet with you. Alana can be contacted on or at Alana.mccorry@education.govt.nz.
