### Education Report: Hato Petera – Consultation Extension Sought from Proprietor

### Purpose of Report

- The Proprietor of Hato Petera College wrote to you on 1 July 2016 requesting to extend the timeframe for consultation about the future viability of the College, from 5 August 2016 to 23 September 2016. This letter is attached as Appendix One.
- This briefing provides you with information about the Proprietor's proposal and possible timelines for consultation. This is attached as Appendix Two.

### Background

- Earlier this year the Proprietor of Hato Petera Collège (College), the Bishop of Auckland, Patrick Dunn, wrote to you seeking your agreement to initiate consultation on the long-term viability of the College. The Proprietor raised concerns about:
  - the low roll, which is not sustainable longer term (the roll is 49 students as at 5 July 2016)
  - an inability to provide effective governance at the College
  - complaints made by the staff of the College concerning the leadership provided by the kaihautu of the College; and
  - breaches of the integration agreement, by failing to meet the correct number of tagged staffing positions and enrolling students over the agreed maximum non-preference roll of five per cent.
- You wrote to the Proprietor on 9 June 2016 agreeing to his proposal to initiate consultation. As the College provides education for Māori students, you asked the Proprietor to also consider, and report back to you, on how he could ensure a strong future for Māori Catholic education in his Diocese. You asked the Proprietor to report the outcome of this consultation by 5 August 2016.
- The Proprietor has sought an extension on this timeframe to 23 September 2016, because:
- of the need to consider a plan for Māori Catholic education in his Diocese, and
- his preferred facilitator is overseas.

### Private Schools Conditional Integration Act 1975 (PSCI Act) – Process for Consultation

Under the PSCI Act, the Minister and the Proprietor enter into an integration agreement, which together with the PSCI Act sets out the terms and conditions of integration of a private school into the state system for both parties. Any change to an integration agreement must be mutually agreed to by both parties.

- Section 11C of the PSCI Act provides for the cancelation of an integration agreement by mutual agreement between you and the Proprietor, following consultation with other interested persons or groups as both you and the Proprietor consider appropriate.
- There is no provision under the PSCI Act that requires you to carry out a second round of consultation if you propose to cancel the integration agreement and close the school. However, section 80 of the PSCI Act states that it should be is construed in a manner consistent with the Education Act 1989 where appropriate and reasonable to do so.
- 9 Section 154(2) of the Education Act 1989 provides for the Board of Trustees of a school to be given an opportunity to provide further argument against closure where closure of a school is proposed.
- Accordingly if an agreement was reached to close the College, and the College Board of Trustees was opposed to the proposed closure of the school, our preference would be to provide the Board with a further opportunity to provide arguments against closure consistent with section 154(2) of the Education Act and section 80 of the PSCI Act.

### **Option Analysis**

Due to the factors outlined above, we have undertaken analysis of three options in relation to consultation timeframes (a detailed assessment of the risks and

benefits of each option and timelines for implementation is provided as Appendix Two). The options are:

### Option A - Current timeframe (Response due by 5 August 2016)

- The benefits of this option is that a decision on the future viability of the College would be made sooner, providing certainty for tamariki and whānau. However, this is not our preferred option because:
  - the timelines for consultation would be so condensed, that it may not result in thorough and meaningful consultation
  - the Proprietor's preferred facilitator is overseas.

### Option B - Proprietor's preferred timeframe (Response due by 23 September 2016)

The benefit of this option is that it would allow for what the Proprietor has requested. However, if the outcome of the consultation does lead to an agreement for closure, this option does not allow for sufficient time for the Ministry to undertake a second round of consultation should it be required.

### Option C – Proposed middle-ground timeframe - Ministry's preferred option (Response due by 12 September 2016)

This is our preferred option as it will allow the proprietor sufficient time to undertake consultation, and in part meet his request for an extension. It allows time for the Ministry to undertake a second round of consultation should it be required. There are some manageable risks associated with this. These are discussed in Appendix Two.

### Ministry Comment

- We recommend that you do not agree to the Proprietor's proposed date of 23 September 2016 to report back on the outcome of the consultation. This would mean, that should both you and the Proprietor agree to cancel the integration agreement, it would not allow adequate time for the Board of Trustees to provide any further arguments, through a second round of consultation.
- 21 If a decision was reached by you and the Proprietor to cancel the integration agreement and close the College, the agreed date for all secondary school closures is 27 January each year. If a second round of consultation was to take place, it is likely that this would not end until mid-November, leaving a final decision being made in early December. We feel that this timing could be too close to the end of the Term for students.
- Our preferred option would allow a "middle-ground" for both parties. This option sees the Proprietor report back on his consultation by 12 September 2016 (five extra weeks). We feel that this is adequate time for the Proprietor to carry out his consultation, and to provide a plan for Māori education in his Diocese.
- Option C is the only proposed option which gives a minimum 8 weeks for consultation while still building in the opportunity to hear further arguments later if necessary in accordance with section 154(2) of the Education Act 1989.

### Update on the current situation at Hato Petera College

- On Friday 30 June 2016, the Manager Education Auckland, Leisa Maddix, at the request of both the Trust Board and the Board of Trustees, facilitated a meeting between members of the Hato Petera College Board of Trustees and the Trust Board. At this meeting it was evident to all parties that the relationship between both groups had deteriorated to a concerning level and statutory intervention is now required.
- We are working to appoint a Limited Statutory Manager (LSM) to support the Board. The LSM is expected to be in place at the beginning of Term 3, 2016 and will support the Board in the following areas:
  - Relationships with the school community
  - Financial management
  - Physical and emotional student safety
  - Board roles and responsibilities
  - Policies and procedures
  - Human resource compliance

### Complaints received from whanau

Last week, we received a complaint from the Principal regarding safety concerns for students in the hostel. The Principal has noted that four families have raised these concerns with the Principal. The hostel is the responsibility of the Proprietor and we will continue to support the whanau, College and Proprietor as we work through these concerns raised.
