

## Timeline of Events

When	Event
16 September 2013	Ngā Parirau Mātauranga was approved to open a Partnership School. Governance Facilitator, Chris Saunders appointed to support the Trust/school.
27 September 2013	Ministry of Education contracts the Education Review Office (ERO) to conduct a school readiness review.
December 2013	ERO submits to the Ministry an interim report on readiness of Te Kura Hourua ki Whangaruru to open in February 2014.
10 February 2014	Te Kura Hourua ki Whangaruru opens with 70 students.
April 2014	ERO submits four of the five readiness reviews [METIS 868887].
April 2014	The Sponsor provides to the Ministry a remedial plan in response to ERO's interim readiness review.
April 2014	Appointment of an interim CEO to the school [REDACTED] Resignation of the Business Manager [REDACTED] s 9(2)(a) OIA
10 May 2014	The Ministry extended the ERO Readiness Review period until the end of August 2014 [METIS 868887].
May – June 2014	A significant number of improvements observed at the school during the interim CEO's tenure. Interim CEO identified that for the school to be a success, the current Education Director needed to be replaced.
June 2014	Resignation of the interim CEO from the school. The Trust did not accept the interim CEO's advice regarding the Education Director.
June 2014	Governance Facilitator contract ends. Chris Saunders concludes his role as governance facilitator at the school
31 July 2014	The Trust submitted to the Ministry its 2 <sup>nd</sup> Quarter Report as required by the contract. The Sponsor was operationally compliant with the Agreement and had achieved all applicable performance standards for that quarter.
2 September 2014	Members of the Authorisation Board visited the school and observed areas of concern. Provided advice to the Ministry and the Sponsor.
8 September 2014	ERO submitted its final draft readiness review report. ERO concluded that the school was not yet in a position to operate effectively without further substantial support.
September 2014	The Trust challenged the findings of the ERO report and provided feedback.
17 September 2014	ERO submitted its final readiness review report following minor adjustments.
17 September 2014	The Authorisation Board requested additional information on a number of areas relating to the performance of the school.
23 September 2014	The Sponsor provided to the Ministry the additional information requested by the Authorisation Board.
1 October 2014	Ministry staff met with the Trust to discuss the issues arising from the ERO readiness review. [REDACTED] (Trust member) fills the CEO position. s 9(2)(a) OIA

31 October 2014	<p>The Trust submitted to the Ministry its 3<sup>rd</sup> Quarter Report as required by the contract. The Sponsor was operationally compliant with the Agreement and had achieved all applicable performance standards for that quarter.</p> <p>School shuts down for the year.</p>

4 February 2015	<p>School re-opens for the new school year.</p> <p>ERO School Assurance Review</p>
