The majority of mokopuna feel our kura is a safe place to be, and is caring and collaborative. Supporting mokopuna to be more conscious about using language in ways that uplift the mana of others when communicating with each other and treating each other respectfully when working together, should address the concerns raised by the small proportion of mokopuna who identified these aspects as an issue for them. While the scale for aggressive behaviour was low, remedial action is still required because these mokopuna reported frequent exposure to negative behaviours associated with student culture in the school. Mana Tāne and Mana Wāhine, where mokopuna are split by gender to discuss aspects including developing a positive school culture, will continue to provide a platform to directly address these issues. Pouako have been asked to refer to the findings of the survey to plan these sessions.

Mokopuna (95%) acknowledge that pouako believe that all mokopuna can do well and 93% report that pouako model the behaviours they expect of mokopuna. Eighty-seven percent report that pouako make learning interesting and 95% feel they are taught that it is OK to be different.

Other areas of strength relate to school-wide climate and practices where the majority of mokopuna reported that they are clear about what to do if someone is being hurt or bullied, that hitting and bullying are not tolerated and the school celebrates and acknowledges the good things they do.

A high proportion of mokopuna feel safe coming to and from school which is an important consideration as public transport is one of the main means of transport. They feel their whānau are always made to feel welcome and there is mutual respect between pouako and their whānau. Higher proportions of mokopuna reported the absence of a parent or adult they can approach outside of school when upset and they live in areas where getting on with each other is an issue.

The quarterly results report a loss. Operational expenses including salaries and teaching resources are steady and remain within budget limits. We do not expect any changes with operational costs and staffing levels for the rest of the year. Occupancy and heating costs are very high and are expected to increase in 2018. Repairs and maintenance of the premises are unusually high this quarter and we expect to reduce this cost for the remainder of 2017. Depreciation is high at \$18,600. We have high transport fees for the school bus service. We are locked into bus rates for 2017 and have organised alternative transport in 2018 to reduce this cost next year. We are still being charged for compliance and set up work from various agencies including Hamilton City Council, an engineering consultancy firm, and local transit agencies with regard to permit fees and licences. These costs are expected to diminish over time.

Working Capital Ratio (Target: at least 2:1)

The Working Capital Ratio indicates a school's ability to meet their short-term financial obligations through sound financial operation. The Working Capital Ratio is calculated by dividing current assets by current liabilities. Te Kopuku High has favourable working capital levels. The kura does not have any short term debt aside from trade creditors. Low debt levels are largely due to assistance from the Sponsor - Kia Ata Mai Educational Trust
