Education Report: Partnership Schools Kura Hourua Authorisation Board Appointments

Purpose of report

1. This report provides you with a Cabinet paper setting out your proposed two new members to be appointed to the Partnership Schools Kura Hourua Authorisation Board (the Board) to go to the Cabinet Appointments and Honours Committee (APH). You are asked to forward the attached paper to the Cabinet Office.

Background

- 2. Cabinet agreed to the establishment of the Board to provide advice to you on the selection of successful sponsors to establish Partnership Schools [CAB Min (12) 26/6 refers].
- 3. The functions of the Board are to:
 - thoroughly evaluate applications for Partnership Schools
 - provide advice and recommendations to the Minister of Education
 - oversee the regular review of each school's progress against agreed achievement targets
 - periodically report to the Minister of Education on each school's performance.
- 4. You approved the final terms of reference for the Board on 13 December 2013 [E1.19388 refers].
- The Board was appointed in February 2013 and currently comprises the chair, the deputy and four members. The current membership of the Board is as follows:

6. The seventh member, Tahu Potiki, advised the Board Chair on 21 March 2014 that he was stepping down from the Board given the additional time required for the second application round. His term on the Board was set to expire on 1 March 2016. Attached is a letter to Tahu Potiki acknowledging his resignation. We request you sign and forward this letter.

7. Two new members have been nominated to be appointed to the Board, one to replace Tahu Potiki and another to add additional educational experience to the Board as agreed with the Board at 22 October 2013 Partnership Schools Debrief meeting.

Nominees

8. The table below outlines the nominees' current position, experience, skills and knowledge.

- 9. The lwi Chairs Forum is supportive of the Partnership Schools polloy and have indicated their interest to have a member serve on the Authorisation Board. Sir Toby Curtis's name was put forward as the lwi Chairs Forum's representative.
- 10. Given the resignation of Tahu Potiki from the Board, having a representative from the lwi Chairs Forum will provide an important perspective and Māori voice that will inform the Board's independent advice to you. This is particularly important given the focus of widening choices and raising achievement for our priority learner groups.
- 11. John Taylor has also been a keen supporter of the Partnership Schools policy and will add strong educational expertise to the Board. John Taylor is the Board Chair's preferred nomination.
- 12. The Board has a balance of gender, age, ethnicity and geographic representation. It also brings together people with expertise and experience in education, business and the community.
- 13. The two nominated members have been asked to complete disclosure forms. They will also be subject to criminal checks which will take up to 21 working days.
- 14. We recommend that they be appointed until 1 March 2016, which is the expiry date for three of the existing members (Catherine Isaac, Terence Bates, and Dr Margaret Southwick).
- 15. John Shewan, John Morris and Dame Iritana Tawhlwhirangi term is still set to expire on 1 March 2015. You agreed to stagger the appointment terms for the Board members to allow for continuity in the Board's work as it progresses and member's terms come up for renewal [Metis 743019 refers].

Conflicts of interest

- 16. The Authorisation Board, supported by the Secretariat, maintain a register of conflicts that record any perceived or actual conflicts of the members and their broader interests. The register sets out the nature of the conflict and the management approach that is to be applied for each recorded instance. Conflicts of interest are an agenda item and are discussed at the beginning of every Authorisation Board meeting.
- 17. The appointment of John Taylor, who was a member of the Partnership Schools Kura Houra Working Group, may be perceived as a conflict of interest. As a member of the Working Group, he may have provided advice to prospective sponsors, whose full applications he will be involved in assessing as a member of the Board.
- 18. Two current members of the Authorisation Board were also members of the Working Group, Catherine Isaac and Dr Margaret Southwick. Any potential conflict this raised did not become an issue in the first application round for Partnership Schools.
- 19. The Working Group was closed down in March 2013, and the applicants for the first application round have been selected and have opened their schools. It is unlikely that Mr Taylor's previous membership on the Working Group will pose any conflict for the second application round.
- 20. Dame Iritana Tawhihirangi is also a serving Board member at Te Kohanga Reo National Trust Board. Recent high profile matters relating to the Trust have occurred. The Ministry is confident that appropriate steps will be taken to manage any potential perceived or actual conflicts of interest that may arise, consistent with the Authorisation Board's terms of reference.

Financial implications

- 21. The costs associated with appointing one replacement member and one new member to the Board can be met by the Ministry within existing departmental baselines.
- 22. The daily rate for the new members is per day as per the Cabinet Fees Framework.

Communications

- 23. The Ministry will liaise with your office about requirements for publicising the appointments and communications with your colleagues and support parties.
- 24. Appointment letters are attached for your signature following Cabinet approval of your two nominees.


