Introduction

- A. Section 158D of the Education Act 1989 (the Act) enables the Minister, in the name and on behalf of the Crown, to enter into a contract with a sponsor for the operation, by that sponsor, of a Partnership School | Kura Hourua in accordance with the requirements set out in the Act.
- B. The Minister and the Sponsor (jointly known as "the parties") are parties to such a contract dated 16 September 2013 to operate a Partnership School | Kura Hourua under the agreed terms and conditions ("the principal Agreement").
- C. On 9 December 2014 the Minister of Education amended the Gazette Notice issued under section 158B of the Act and which approved the Sponsor to operate a partnership school for class levels 1-6 inclusive to also include years 7 and 8 in the class levels for which education may be given at the school.
- D. The Minister and the Sponsor also amended the principal Agreement on 9 December 2014, to increase the Maximum Roll of the school and to provide for performance standards reflecting the addition of years 7 and 8 to the class levels for which education may be given at the school ("First Variation").
- E. The Second Variation agreement further amended the principal Agreement (as amended by the First Variation) as required for the 2015 school year.
- F. This **Third Variation** agreement further amends the principal Agreement (as amended by the First Variation and Second Variation) as required for the 2016 school year.

Effective Part

Amendments to the principal Agreement

The parties agree to vary the principal Agreement with effect from the effective date by:

(a) the deletion of clause 18.7 and replacement with the following:

"18.7 Reporting generally

Nothing in clause 18 of this Agreement alters or affects the Sponsor's other obligations under the Act or any other enactment to report on matters that it may be required to report on by law, including without limitation reporting to the Education Council in accordance with any relevant provision in Part 32 of the Act."

(b) in clause 35.1 deletion of the definition of 'Holders of Limited Authority to Teach' and replacement with the following:

B

"Holders of Limited Authority to Teach means a person who has been authorised under section 366 of the Act as having a limited authority to teach, whose authorisation has not been suspended under section 402 or 404(1)(d) of the Act."

(c) in clause 35.1 deletion of the definition of 'Registered Teacher' and replacement with the following:

"Registered Teacher means:

- a person listed on the register (kept by the Education Council pursuant to section 359 of the Act) whose registration has not been cancelled, or whose registration has been cancelled but who has subsequently been re-registered;
- (ii) a person holding a practising certificate as defined in section 348 of the Act that has not been suspended under section 402 or 404(1)(d) of the Act;
- (iii) any person who has an authorisation that has not been cancelled unless that person has been authorised again or has been registered as a teacher (register, registration, authorised, and authorisation having the meanings set out in section 348 of the Act)."

(k) The deletion of clause 1.4 of Schedule 7 and replacement with the following:

1.4 Quarterly Operational Payments

(a) From the 2014 Year, the Sponsor will receive Quarterly Operational Payments from the Minister which will be calculated by the Ministry and will be comprised of sums relating to the various payment types set out in the following table:

Per student funding	25% of the annual per student funding amount multiplied by the number of Students enrolled at the school at the time of payment calculation.	Consumers price index and labour cost index

- (b) The Quarterly Operational Payment for the 2016 Year is \$210,255.06 (exclusive of GST).
- (c) The Quarterly Operational Payment for any Year from 2017 onwards will be determined by the Ministry on behalf of the Minister in accordance with the framework described in paragraphs (a) and (e) to (i) of this clause 1.4.
- (d) Quarterly Operational Payments are paid at the beginning of the quarterly period to which the funding relates in order to provide the Sponsor with funds from which to operate and manage the School.
- (e) As indicated in the third column of the table in paragraph (a) of this clause 1.4, In respect of the "base funding" and "per student funding" components that the Ministry will use to calculate Quarterly Operational Payments, the payment adjustment mechanism that will be used by the Ministry will be the consumers price Index and the labour cost Index. During the third quarter of each Year, the Minister shall calculate through a combined use of the labour cost index and the consumers price Index a percentage change to the base funding and per student funding amounts. This adjustment will take effect from the first quarter of the next Year. The percentage of each of the base funding and per student funding amounts that will be adjusted by the labour cost Index and the consumers price index will be as follows:
 - (i) Labour cost index = 70%; and
 - (ii) Consumers price index = 30%
- (f) As Indicated in the third column of the table in paragraph (a) of this clause 1.4, in respect of the "property and Insurance funding" and the "centrally funded support" components that the Ministry will use to calculate Quarterly Operational Payments, the payment adjustment mechanism that will be used by the Ministry is that the Ministry will review the payments once in every three year period and may, following a review, determine that the underlying payment amounts used in any calculations should be adjusted.



- (g) For the purpose of any calculations that are relevant to determining a Quarterly Operational Payment where the School's decile rating is a factor in the calculation, the School's decile will be deemed to be three. Any new decile rating that is provided by the Ministry (either following a request for a decile review from the Sponsor, or otherwise) will be deemed to be the new decile rating that applies to the School for the purpose of this clause.
- (h) For the 2014 to 2016 Years, for the purpose of determining any funding component described in the table in paragraph (a) of this clause 1.4 where the School's roll is used to calculate a payment, the School's roll will be deemed to be the Guaranteed Minimum Roll that applies as at the payment date or the actual roll submitted through relevant roll returns (whatever number is greater).
- (i) Quarterly Operational Payments will be made on the following basis:
 - (i) 99% of each Quarterly Operational Payment will be payable during the term of this Agreement on the 20th Business Day of the month following receipt of an invoice from the Sponsor provided in accordance with clause 2 of this Schedule 7 (Invoicing); and
 - (ii) the remaining 1% of each Quarterly Operational Payment will be retained by the Minister and, following the Minister's receipt and consideration of the Sponsor's Annual Report, will be paid to the Sponsor provided that the Minister is satisfied, in the Minister's sole discretion, that the Sponsor has met all of the Performance Standards for the relevant School Year to which the Annual Report relates by the end of the relevant School Year.

3. Effective Date

The provisions of this Third Variation will come into effect on the date this Third Variation is signed by both parties ("Effective Date").

4. General Provisions

- 4.1 This Third Variation is intended to supplement and form part of the terms and conditions contained in the principal Agreement. The parties declare that the terms and conditions set out in the principal Agreement remain in full force and effect except to the extent that they have been amended or added to in this Third Variation or any other validly executed variation Agreement.
- 4.2 If there is any conflict between the terms and conditions contained in the principal Agreement and the terms and conditions set out in this Third Variation, the terms and conditions of this Third Variation will prevail.
- 4.3 Headings, underlining and bold type are for convenience and do not affect the interpretation of this Third Variation, unless the context requires otherwise.
- 4.4 Each party will do, execute and perform all such acts, deeds, matters and things as may be reasonably required by the other party to enable them to obtain the full benefit and advantage of the terms, intent and meaning of this Third Variation.
