Education Report: Partnership Schools | Kura Hourua Contract Variations 2016

Purpose of Report

- 1. This report asks you to
 - a. confirm and sign Variation Agreements for seven Partnership Schools for 2016;
 - b. issue a notice in the New Zealand Gazette correcting the name and clarifying part of the aims, purposes and objectives of one Partnership School.

Finalisation of Variation Agreements for 2016

- 2. You approved Variation Agreements for the eight current Partnership Schools on 4 May 2016 [METIS 979850 refers].
- 3. These were to be sent to Sponsors for signing, and returned to you for final signing.
- 4. The Variations were sent to Sponsors. Some minor alterations were requested, as detailed below. We have made these alterations and all Variation Agreements have been signed by Sponsors. These are now ready for you to sign.
- 5. We acknowledge that this has been a drawn out process, resulting in Variation Agreements being signed too late in the year. A number of measures are being taken to bring this timeline forward. They include beginning negotiations earlier in the previous year, and removing overly prescriptive details in the Agreement Schedules that currently need annual updating. The end of Guaranteed Minimum Rolls will also reduce the annual workload required for Variations.
- 6. The Variation for Pacific Peoples Advancement Trust allowed for insertion of a *Gazette* notice correcting its name from Pacific Advancement Senior School to Pacific Advance Senior School. The current *Gazette* notice (notice 2014go5837, issued on 18 September 2014, incorrectly named the Trust's school 'Pacific Advancement Senior School'.
- 7. Also, the current *Gazette* notice does not refer to the inclusion of practices and instruction in the Christian faith. This is an inherent part of the school's character, discussed during the application phase of its establishment. The ability to provide religious instruction to students during school hours is included in the 2016 contract variation for this School, as the Sponsor had raised this for clarification during 2015.
- 8. This clarification of the Christian faith being part of the School's inherent character needs to be recognised via the *Gazette* notice, pursuant to section 158B of the Education Act 1989. A draft *Gazette* notice is attached as Appendix Two.

- 10. Clause (i) did not allow for provision of religious instruction. The Sponsor is concerned about current legal action around religious instruction and the use of karakia in schools. We have added the ability to provide religious instruction within that context. The *Gazette* notice for this School provides for kaupapa Māori philosophy, Māori culture and world view. In the context of the request we do not consider it needs updating.
- 11. Clause (j) of the original variation provided for the following mix of teaching staff for 2016:

- 13. The 2017 Variations will update the term "registered teacher" to "holder of a practising certificate", in line with changes to the Education Act 1989.
- 14. Clause (k) originally set the percent of curriculum time taught by Registered Teachers and holders of Limited Authority to Teach for 2016 at 70 percent. This was inconsistent with the average of 60 percent over 2014 to 2018. The Sponsor therefore requested it be changed to 60 percent to be consistent with the average.
- 15. Clause (m) listed the four years' NCEA performance standards as follows:

19. Clauses (I) and (m) of the Variation Agreement altered clause 1.4 of Schedule 7 of the Agreement and tidied up a renumbering issue. This was done for all Variations. This Sponsor found this difficult to follow and requested that we replace the whole clause, as it would appear following amendment, in the Variation to avoid further confusion. This has been done.

Next Steps

20. The Sponsor-signed Variations need to be signed by you to become part of the respective Agreements.

- 21. A *Gazette* notice needs to be issued to correct the name of, and allow for religious instruction at, Pacific Advance Senior School.
- 22. We will include the signed Variations, this Education Report, and the initial Education Report on these Variations, in the next available Ministry of Education proactive information release, in consultation with your Office.
