Education Report:

Approval of Sponsors to operate a Partnership

School | Kura Hourua from 2017 - Contracts

Executive Summary

On 18 April 2016 you gave approval for the Ministry of Education to enter into contract negotiations on your behalf with three preferred applicants to operate a Partnership School Kura Hourua from 2017.

These were:

- Kia Ata Mai Educational Trust
- Te Aratika Charitable Trust
- Te Whānau o Waipareira

Contract negotiations with two of the three parties have now been successfully concluded and we ask you to sign a contract with each of these parties.

The third preferred applicant, Te Whānau o Waipareira, elected in mid-July 2016 to withdraw their application.

The Ministry has applied a risk assessment methodology with a particular focus on financial sustainability to this round of negotiation. This is to ensure the preferred applicants and the Ministry are clear on the types of risk and possible mitigations through the establishment phases of the schools. Ensuring financial sustainability has been a key consideration under the revised funding model, particularly whilst the school roll is building over the first year of operating.

The two remaining preferred applicants have yet to make a final decision on the premises for their schools. Each party is required confirm their premises at least 90 days prior to the opening of their schools, as required in the Partnership Schools Kura Hourua Agreement.

The estimated cost to establish and operate the two schools is \$5.825m over four years consistent with the amount agreed by Cabinet [SOC-16-MIN-0037 refers], less the funding attributed to the third preferred applicant. Subject to your agreement and appropriate Cabinet approvals we propose to set aside the surplus resulting from only two of the three schools being established, and use this to offset the cost of any schools approved in either round four or five.

We now recommend you:

- sign the contracts for the two preferred applicants to be sponsors of a Partnership School | Kura Hourua pursuant to section 158D of the Education Act 1989; and
- sign and date the attached Gazette notices to be published in the New Zealand Gazette.

Recommendations

We recommend that you:

- a. **note** that we have approached the negotiation of the third round of application by applying a risk assessment methodology with a particular focus on financial sustainability.
- b. **note** that, following your earlier decisions, the Ministry has successfully negotiated contracts with the following sponsors for the establishment of a Partnership School | Kura Hourua from 2017:
 - Kia Ata Mai Educational Trust
 - Te Aratika Charitable Trust
- c. **note** that Te Whānau o Waipareira elected in mid-July 2016 to withdraw its application.
- d. **note** that the cost to establish two schools is projected to require \$5.825m of the \$9.800m appropriated for this purpose over the first four years.
- e. **note** that we recommend any surplus is used to offset the cost of any schools approved in either round four or five, subject to your agreement and Cabinet approval.
- f. **note** that of the issues identified in the advice on which applicants to be taken forward to contract negotiations [METIS 985894], with the exception of confirming property arrangements, all have been satisfactorily resolved, or an acceptable plan agreed.
- g. **agree** to sign contracts to operate a Partnership School | Kura Hourua for 2017 with:
 - Kia Ata Mai Educational Trust

Education Report: Approval of Sponsors to operate a Partnership School Kura Hourua from 2017 - Contracts

Purpose of Report

- 1. This report seeks your agreement to:
 - sign contracts with two of the recommended applicants to operate a Partnership School | Kura Hourua from 2017;
 - sign the New Zealand Gazette notices approving the two as sponsors and establishment of the Partnership Schools; and
 - release documents relating to this application round for operating Partnership Schools | Kura Hourua.

Background

- 2. Section 158D of the Education Act 1989 gives the Minister of Education the power to enter into a contract with the sponsor of a Partnership School | Kura Hourua.
- 3. Following an application and evaluation process carried out in accordance with the requirements of whole of government procurement activities across 26 applications, you received advice from the Authorisation Board and from the Ministry of Education [METIS 985894 refers] on which applicants should be considered for the contract negotiations.
- 4. In April 2016 you advised Cabinet of your intention to select three applicants to enter into contract discussions. Cabinet noted your intention and approved changes to appropriations to establish the third round of Partnership Schools Kura Hourua [CAB Min (16) 0163 refers].
- 5. On 18 April 2016 you confirmed your decisions on the preferred applicants for the Ministry to initiate contract discussions with [METIS 985894]. They were:
 - Kia Ata Mai Educational Trust
 - Te Aratika Charitable Trust
 - Te Whānau o Waipareira
- 6. The Ministry has been negotiating with the three applicants on your behalf since early May 2016.

Negotiations

- 7. For Kia Ata Mai Educational Trust and Te Aratika Charitable Trust, all of the issues identified in the advice on which applicants should be taken forward to contract negotiations [METIS 985894], with the exception of confirming property arrangements, have been satisfactorily resolved, or an acceptable plan agreed.
- 8. Te Whānau o Waipareira, also satisfied the issues that were identified and had initially agreed to the requirements and the terms and conditions set out in the agreement. In early-July 2016 the Trust sought to alter the agreement to include a binding and formal recognition of its iwi status determined by the Waitangi Tribunal under the Wai 414 judgment.

9. We advised that the Crown was not willing to consider this alteration to its standard terms and conditions at such a late stage in the negotiations. This resulted in the Trust publicly announcing that it was withdrawing from the application process.

Approval

- 10. The Ministry has now successfully completed the contract negotiations and the two remaining preferred applicants have now signed their agreements. An overview of each applicant and their proposal is provided in Appendix 1.
- 11. We recommend you now sign the contracts.

Sponsor Readiness

12. We confirm that we consider adequate plans are in place and that all sponsors are in a position to commence establishing their schools to open in February 2017. An update on these issues is provided below:

Kia Ata Mai Educational Trust

- 13. Kia Ata Mai Educational Trust has identified a preferred site of the school, but has yet to confirm this formally. The Trust is required under the contract to confirm its premises at least 90 days prior to opening their school.
- 14. The Trust has noted that the funding provided in the third round requires them to invest a relatively significant amount into the establishment of the school. The Trust confirms that it has set aside additional cash reserves to cover operational costs in the event that they are unable to attract the required number of students to meet its break-even point.

Te Aratika Charitable Trust

- 15. Te Aratika Charitable Trust has yet to confirm the location of the school, but has identified a preferred site. The Trust is required under the contract to confirm its premises at least 90 days prior to opening their school.
- 16. The Trust in its original application proposed a residential facility as critical to support the development of foundation skills and support the learning journey of the students it intends to attract. Provision of a hostelling solution is not part of the contract to operate a Partnership School, and remains subject to the Trust meeting the legislative requirements to operate such a facility and securing the necessary funding to do so. The Trust has confirmed that it intends to progress the establishment of a residential facility.
- 17. The Trust has noted that it has a willingness to invest to cover operational costs in the event that they are unable to attract the required number of students to meet its breakeven point.

Financial Considerations

18. As part of Budget 2015, an operating contingency was set aside for the establishment of Partnership Schools [CAB Min (15) 12/2(8) refers]. We advised in April 2016 [METIS 895394] that the available funding was sufficient for a maximum of three schools to open in 2017 (with particular roll levels) with utilisation of the provision for annual cost increases and roll growth to meet an eventual shortfall in the outyears.

- 19. The cost to establish and operate the three proposed schools was projected to require the full \$9.800m appropriated for this purpose over the first four years.
- 20. The final cost to establish two of the schools is \$5.825m over the first four years. Subject to your agreement and appropriate Cabinet approval, we propose to set aside the surplus resulting from only two of the three schools being established, and use this to offset the cost of any schools approved in either round four or five.
- 21. As funding for the third round is payable on a per-student basis, actual costs will be variable whilst the schools grow to their maximum rolls. The Ministry will need to monitor the actual costs against the projected costs and utilise the provision for annual cost increases and roll growth, if the schools reach their maximum roll more rapidly than anticipated.

Contractual Matters

- 22. You agreed to a number of enhancements to the draft agreement issued with the round three application [METIS 945671 refers]. Through the negotiation process, we have further refined details of the agreement.
- 23. The most significant refinement has been to remove the school's objectives and the financial performance standards from your consideration on whether they should be paid the 1% of funding held in retention. This change comes about to better reflect the policy intent of focusing on student outcomes.
- 24. Other key changes to the agreement through the negotiation phase include:
 - Addition of Ngā Whanaketanga Rumaki Māori standards to recognise Māori medium provision;
 - Addition of the school curriculum handbook as an operative document and a requirement to make this publicly available;
 - Addition of further grounds to terminate the agreement where the sponsor fails to meet the or cannot demonstrate it has made every reasonable effort to meet the milestones set out in its establishment plan; and
 - Clarity on how the schools assets would be valued in a termination event.
- 25. Refer to Appendix 2 for a table setting out the remainder of the changes that have been made to the contract.

Contractual Off-Ramps prior to opening of the school

- 26. Sponsors are required to confirm and/or deliver a number of artefacts during the establishment period each of which collectively, or on their own, could trigger the Crown's right to intervene.
- 27. Sponsors must:
 - provide their parents, family, whānau, iwi and community engagement policy by 1 October;
 - provide their health, safety and wellbeing policies, and curriculum handbook by 1 November; and

- confirm their intended property a minimum of 90 days prior to opening.
- 28. In addition, the Minister may terminate the agreement if the Sponsor fails to meet or cannot demonstrate it has made every reasonable effort to meet the milestones set out in its establishment plan.
- 29. The contract provides the Minister with a general ability to intervene if she has any reason to believe that a sponsor is failing to discharge their duties under the Act or is otherwise not acting in accordance with the Act (or any other applicable laws) or their agreement such that there are reasonable grounds to believe that there is a risk to the operation of the school. This option does not require the intervention framework to be followed.
- 30. Therefore, through the ERO readiness review, the delivery of the requirements set out above (including the need for Sponsors to meet their own establishment milestones), and potentially any notification/concern raised by the Governance Facilitator, the Ministry will be able to make an assessment of the sponsor's readiness to open in early November. This will enable the Minister to make a decision to prevent the school from opening by the end of November, if required.
- 31. If a decision were made to prevent a school from opening, it would be done through clause 22 (General ability to intervene) and clause 25.1 (Minister's right to terminate). The Minister would be required to issue a notice of intention to terminate. This would then provide the sponsor ten days to respond with reasons why the agreement should not be terminated.
- 32. If the sponsor were able to address the issues and/or provide the required level of assurance, then the Minister need take the matter no further. Otherwise, the Minister could issue a notice of termination taking effect at a minimum of 20 business days from the date of that decision.
- 33. As the termination event occurred in the first three years of the agreement, the sponsor would be obligated to pay the Crown the set-up component of the establishment grant (\$400k for secondary schools), or an amount equal to the value of the school's assets (where the asset value is less than \$400k).

Performance Standards

- 34. The values of the required Student Engagement and Financial Performance Standards are the same as required from the already established Partnership Schools | Kura Hourua.
- 35. The Student Achievement targets for National Standards and Ngā Whanaketanga Rumaki Māori set at 85% for 2018, the second year of operation.
- 36. For its first year of operation Kia Ata Mai Educational Trust has set its performance standards at the higher of the Waikato and national achievement outcomes for 2015 for Ngā Whanaketanga Rumaki Māori and National Standards.
- 37. In accordance with our previous advice to you on Partnership Schools | Kura Hourua NCEA Performance Standards [METIS 1009972 refers], the following NCEA performance standards will apply:
 - a. 85% roll based NCEA pass rates as defined and reported by NZQA to apply from 2018; and

- b. 85% of School Leavers with NCEA level 2 (or above) to apply from 2019.
- 38. For 2018, being the first year that it will offer NCEA level 2, Te Aratika Charitable Trust has set its 'NCEA level 2 or above' leaver rate at the national outcome for Māori boys in 2014. For 2019 the target is 85% of school leavers getting NCEA level 2 or above.

Communication

- 39. The Ministry has developed a communications plan and will engage with your office, the office of the Under-Secretary, and sponsors to announce the establishment of the successful Partnership Schools.
- 40. Following your agreement and approval of the contracts, we will provide this Education Report and a copy of the signed contracts to the Authorisation Board.
- 41. The Ministry will also proactively release the signed contracts, this Education Report and the successful applicants' proposals on the Ministry of Education website following your agreement.

New Zealand Gazette Notices

- 42. The Ministry has prepared two establishment notices for the *New Zealand Gazette* for you to sign and date. Notice in the *New Zealand Gazette* is required to formally approve the sponsors and to establish the schools.
- 43. Once signed and dated, the notices need to be returned to the Ministry so they can be sent to the *New Zealand Gazette* for publication.

Information Being Released

- 44. The documents to be released are as follows:
 - a. Application templates and documents (previously available on GETS):
 - b. Applications from the five shortlisted applicants;
 - c. Education Reports on progress with the assessments;
 - d. Cabinet Paper seeking approval for contract discussions to begin with the recommended Sponsors to open Partnership Schools;
 - e. Signed Agreements with the two selected Sponsors.
- 45. As there were 26 applications the total amount of information to be released is considerable. It is therefore proposed to initially release only the applications from the five shortlisted applicants, along with the Education Report, Cabinet Paper, and application templates and documents. The remaining applications will be released as resources permit.
- 46. A full list of the information proposed to be released initially is attached as Appendix 3 (with redacted copies of the documents).
- 47. It is also proposed to re-release the following documents with redaction of references to the Third Round removed. These documents also have reference to

the Partnership School Kura Hourua support entity, and those redactions have also been removed ready for re-release [METIS 1000861 refers]:

- a. 924404 Proposed Changes to the PSKH Funding Model and Establishing a Contingency for Round 3 PSKH;
- Cabinet Paper: Partnership Schools | Kura Hourua: Monitoring and Evaluation, Proposed New Funding Model, Operational Review, and Further Application Round; and
