Thank you for your email of 21 February 2017 requesting the following information:

Could you please provide a list of Otago state and state-integrated schools that posted net operating deficits in the 2015 and 2016 financial years and what the deficits are (\$). It would also be great if the ministry could provide some comment around the figures.

Your request has been considered under the Official Information Act 1982 (the Act).

A school's operating balance (surplus or deficit) is just one measure of a school's financial health, and should be seen alongside other measures, such as working capital, retained earnings and cash reserves. We look at all these financial indicators in assessing a school's situation, as well as looking at the pattern over previous years.

An operating deficit may be short-term, or may be balanced by large cash reserves. Schools may also plan to run a deficit as part of a strategic plan to provide additional resources or particular programmes to students over a particular time frame. It would be misleading to suggest that an operating deficit, on its own, is indicative of financial issues at a school.

Approximately 40% of schools in the Otago region recorded net operating deficits in the 2015 financial year (1 January to 31 December). This is consistent with the national level figures that year with approximately 38% of schools recording a net operating deficit. The number of Otago schools reporting an operating deficit in 2015 was down slightly from 62 schools reporting an operating deficit the previous year.

I have attached, as **Appendix One**, a list detailing the Total Comprehensive income<sup>1</sup> of those schools in the Otago region which posted net operating deficits for the 2015 calendar year. To set these figures in the appropriate context, I have also included the retained earning balance<sup>2</sup> of each of those schools. As you will see, each of the schools had a positive retained earning balance over the period in guestion.

<sup>&</sup>lt;sup>2</sup> Operating surpluses from previous years which may be used, for example, to repay debt or be reinvested into the operations of the school at a future time.

Where schools have persistent financial difficulties, we offer Boards of Trustees additional support and advice. These measures can include:

 Discretionary funds which provide schools with support intended to resolve issues as quickly as possible, including meeting the cost of a statutory intervention where a school cannot meet this cost themselves. Statutory interventions provide independent expertise and a fresh perspective to issues that a school has been struggling to resolve.

 Where appropriate, we can provide a capital injection for schools with high debt levels.

- We may recommend the appointment of a Specialist Advisor, who assists the board with this particular aspect of their governance role.

- We can appoint a Limited Statutory Manager, or dissolve the school board and appoint a Commissioner.

We do not hold operating deficits data for the 2016 year. As indicated above, the financial year for schools ends on 31 December and the annual reporting process is just commencing. Schools have until 31 March to submit their annual accounts to auditors for the annual audit and the statutory deadline is 31 May for audited financial statement to be submitted to the Ministry. For this reason, I am refusing this part of the request under section 18(e) of the Act as the requested information does not yet exist.

I trust the information provided is of assistance. Should you have any concerns with this response, I would encourage you to raise these with the Ministry.
