- A. By an Integration Agreement dated 22<sup>nd</sup> December 1998 between the Minister and the Proprietor ("**Integration Agreement**"), the School was established as a State integrated school.

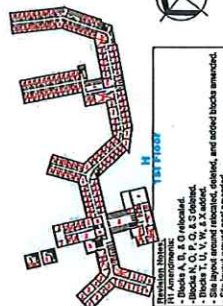
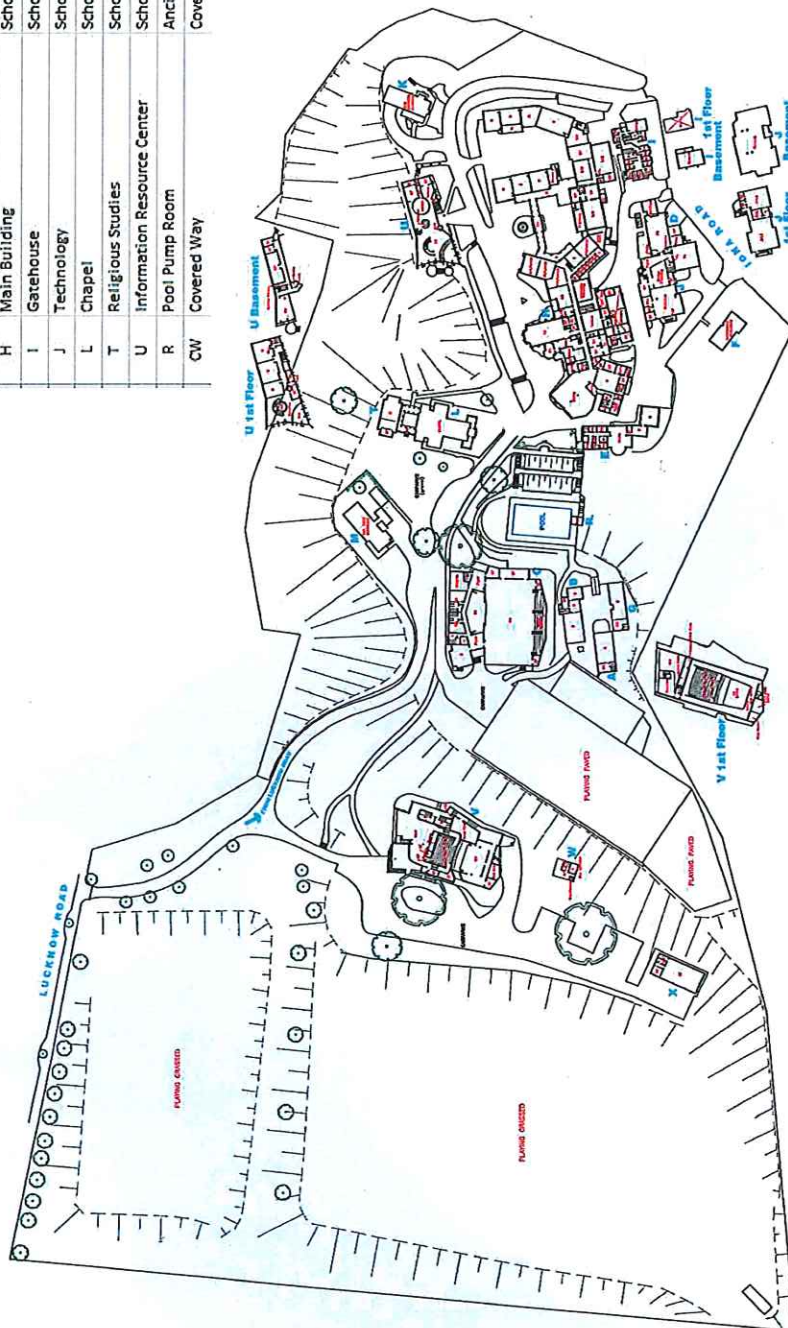
