His Majesty the King in right of New Zealand acting by and through the **Minister of Education** ("the Minister")

and

The Roman Catholic Archbishop of the Archdiocese of Wellington ("the Proprietor"),

together **the Parties**

in relation to **CHANEL COLLEGE, MASTERTON** ("the School").

Background

- A. By an Integration Agreement dated **26 October 1981** between the Minister and the Proprietor ("**Integration Agreement**"), the School was established as a State integrated school.
- B. The Parties have agreed to amend the Integration Agreement on the terms below. The Integration Agreement will be read subject to the modifications set out in this Supplementary Agreement from the date this Supplementary Agreement is executed by the Parties, and any references to the Private Schools Conditional Integration Act 1975 will be treated as references to the corresponding provisions of the Education and Training Act 2020.


- 1 The Plan annexed to the Second Schedule of the Integration Agreement is deleted and replaced with the Plan annexed to this Supplementary Agreement.
