This Supplementary Agreement is made on the 11 day of January 2022

between:

Her Majesty the Queen in right of New Zealand acting by and through the **Minister of Education** ("the Minister")

and

The Christian Schools' Trust ("the Proprietor"),

together **the Parties**

in relation to **ASHBURTON CHRISTIAN SCHOOL, ASHBURTON** ("the School").

Background

- A. By an Integration Agreement dated **1st July 2011** between the Minister and the Proprietor ("**Integration Agreement**"), the School was established as a State integrated school.
- B. The Parties have agreed to amend the Integration Agreement on the terms below. The Integration Agreement will be read subject to the modifications set out in this Supplementary Agreement from the date this Supplementary Agreement is executed by the Parties, and any references to the Private Schools Conditional Integration Act 1975 will be treated as references to the corresponding provisions of the Education and Training Act 2020.
