

SUPPLEMENTARY DEED OF AGREEMENT

ST JOSEPH'S SCHOOL, NEW PLYMOUTH



THIS DEED OF AGREEMENT is made on the 28 day of August two thousand and fifteen (2015) between **THE ROMAN CATHOLIC BISHOP OF PALMERSTON NORTH** a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 12th day of January one thousand, nine hundred and eighty three (1983) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **St Joseph's School, New Plymouth** as an integrated school (hereinafter referred to as "the school").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** the words "two hundred and eighty (280) pupils " in the 4th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "three hundred and ten (310) pupils subject to the Proprietor providing adequate teaching space" be substituted therefor.
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

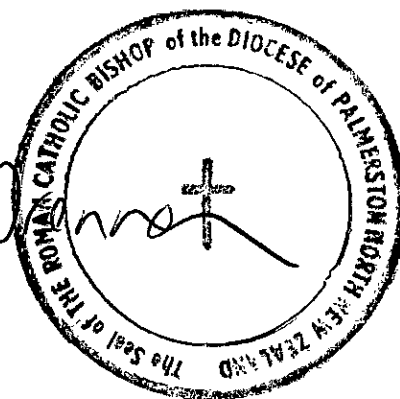
