## SUPPLEMENTARY AGREEMENT

Signed as a Deed.

This Supplementary Agreement is made on the 22<sup>nd</sup> day of April 2022

between:

Her Majesty the Queen in right of New Zealand acting by and through the Minister of Education ("the Minister")

and

Elim Proprietors Trust ("the Proprietor"),together the Parties

in relation to Elim Christian College, Howick, Auckland ("the School").

## Background

- A. By an Integration Agreement dated 6 June 1977 between the Minister and the Proprietor ("Integration Agreement"), the School was established as a State integrated school.
- B. The Parties have agreed to amend the Integration Agreement on the terms below. The Integration Agreement will be read subject to the modifications set out in this Supplementary Agreement from the date this Supplementary Agreement is executed by the Parties, and any references to the Private Schools Conditional Integration Act 1975 will be treated as references to the corresponding provisions of the Education and Training Act 2020.

## **Amendments**

- Clause **twenty** of the Integration Agreement is **varied** and replaced with the following:
  - (a) The words "the 200 additional students allowed to be enrolled in 2018, the further 100 students allowed to be enrolled in 2019 and the further 50 students allowed to be enrolled in 2020" be replaced by the words "four hundred and seventy (470) students".
