

## SUPPLEMENTARY DEED OF AGREEMENT

### HILLVIEW CHRISTIAN SCHOOL, CHRISTCHURCH

THIS DEED OF AGREEMENT is made on the <sup>nineteen</sup> 25 day of February two thousand and ~~eighteen~~ (2018) BETWEEN **SOUTH CITY CHRISTIAN EDUCATION TRUST INCORPORATED**, being the proprietor of Hillview Christian School, the proprietor being a body duly incorporated under the Charitable Trusts Act 1957 (with its assigns and successors, "the Proprietor") AND HER MAJESTY THE QUEEN IN RIGHT OF NEW ZEALAND, acting by and through the Minister of Education ("the Minister").

### WHEREAS




- A By Deed of Agreement dated 1 September 1995, as varied by any subsequent supplementary agreements ("the Deed of Agreement") the Minister and the Proprietor, pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975, established Hillview Christian School, Christchurch, as a state integrated school ("the School")
- B The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 423(3) of the Education Act 1989.

### THE PARTIES AGREE AS FOLLOWS:

1. THAT the two clauses in the Deed of Agreement numbered 26 be deleted and replaced with the following:
 

"25. The proportion of teaching positions other than the positions of Principal and Director of Religious Studies that, pursuant to section 464(c)(i) of the Education Act 1989 are positions of importance carrying a responsibility for religious instruction, is one hundred percent (100%) of the Total Staffing Entitlement of the School."
2. THAT the Deed of Agreement shall be construed subject to the modifications agreed in this agreement and with references to the repealed Private Schools Conditional Integration Act 1975 being read as references to the replacement corresponding sections in the Education Act 1989, but in all other respects the Deed of Agreement is confirmed.
