

## SUPPLEMENTARY DEED OF AGREEMENT

### OUR LADY OF THE SACRED HEART SCHOOL, EPSOM, AUCKLAND

THIS DEED OF AGREEMENT is made on the 26 day of September two thousand and eighteen (2018) BETWEEN **THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND**, a "Corporation Sole" (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

### WHEREAS

- A** By Deed of Agreement bearing date the 28<sup>th</sup> day of September, one thousand nine hundred and eighty two (1982) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Our Lady of the Sacred Heart School, Epsom, Auckland** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to amend Clauses B and 23 of the Deed of Agreement pursuant to section 423(3) of the Education Act 1989.

### NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT** the words " girls from new entrants to Form Two (2) and boys from new entrants to Standard Four (4)" be deleted from the Integration Deed of Agreement and the words " girls and boys from Year 1 to Year 6" be substituted therefor.
- 2. THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
