SUPPLEMENTARY AGREEMENT

Background

- A. By an Integration Agreement dated 4 May 1992 between the Minister and the Proprietor ("Integration Agreement"), the School was established as a State integrated school pursuant to the Private Schools Conditional Integration Act 1975.
- B. The Parties have agreed to amend the Integration Agreement on the terms below. The Integration Agreement will be read subject to the modifications set out in this Supplementary Agreement from the date this Supplementary Agreement is executed by the Parties, and any references to the Private Schools Conditional Integration Act 1975 will be treated as references to the corresponding provisions of the Education Act 1989.

Amendments

- 1. Clause 20 of the Integration Agreement is varied as follows:
 - 1.1. By inserting the following words at the beginning of the clause
 - "(a) Subject to paragraph (b) of this clause"
 - 1.2. By inserting the following after the new paragraph (a):
 - "(b) The maximum roll is 335 from 2020 until 2023 inclusive."
- 2. Clause 23, line 6, of the Integration Agreement is varied by replacing the number "16" with the following:

"five percent (5%) of the maximum roll."
