

## SUPPLEMENTARY AGREEMENT

Signed as a Deed.

This Supplementary Agreement is made on the 11th day of December 2023

between:

**His Majesty the King in right of New Zealand** acting by and through the **Minister of Education** ("the Minister")

and

**Bethlehem College Limited** ("the Proprietor"),

together **the Parties**

in relation to **Bethlehem College, Tauranga** ("the School").

### Background

- A. By an Integration Agreement dated **16 September 1999** between the Minister and the Proprietor ("**Integration Agreement**"), the School was established as a State integrated school.
- B. The Parties have agreed to amend the Integration Agreement on the terms below. The Integration Agreement will be read subject to the modifications set out in this Supplementary Agreement from the date this Supplementary Agreement is executed by the Parties, and any references to the Private Schools Conditional Integration Act 1975 or Education Act 1989 will be treated as references to the corresponding provisions of the Education and Training Act 2020

### Effective date

The effective date of this agreement is Term 1 2024.

### Amendments

- 1 Clause sixteen (16) of the Integration Agreement is **varied** and replaced with the following:
- "16 The maximum roll of the school shall remain the same at one thousand nine hundred and sixty (1960) pupils. Including one hundred and fifty (150) places at Year 1-8 at the Chapman campus in Rotorua. A maximum of one hundred (100) places at Year 1-13 at the Tauranga campus for residents of Rotorua Territorial Authority area remains the same."
