

SUPPLEMENTARY AGREEMENT

Signed as a Deed.

This Supplementary Agreement is made on the 5th day of April 2024

between:

His Majesty the King in right of New Zealand acting by and through the **Minister of Education** ("the Minister")

and

Trustees of the Christian Brothers New Zealand ("the Proprietor"),

together the Parties

in relation to **St Thomas of Canterbury College, Christchurch** ("the School").

Background

- A. By an Integration Agreement dated **19 October 1981** between the Minister and the Proprietor ("**Integration Agreement**"), the School was established as a State integrated school.
- B. The Parties have agreed to amend the Integration Agreement on the terms below. The Integration Agreement will be read subject to the modifications set out in this Supplementary Agreement from the date this Supplementary Agreement is executed by the Parties, and any references to the Private Schools Conditional Integration Act 1975 or Education Act 1989 will be treated as references to the corresponding provisions of the Education and Training Act 2020

Amendments

- 1 Clause **B** of the Integration Agreement is **deleted** and replaced with the following:
 - (a) The school is for boys only and is a Roman Catholic secondary school from Year 9 to Year 13 from 2027. Phasing out Year 7 in 2025 and Year 8 in 2026. The school offers education with a special character.
- 2 Clause **eight** of the Integration Agreement is **deleted** and replaced with the following:
 - (a) The maximum number of students who may be enrolled in the school shall be six hundred and eighty five (685)."
 - (b) The increase is conditional on property provision, and you will need to provide updated site plans to the Ministry before the increase can be implemented.
