### TSP Access Role Information (\* Fields denoted with an asterisk \* are mandatory)

**Transport Service Provider Route-Group Administrator** allows Transport Service Providers to log in and submit monthly performance metrics on behalf of their organization. This role can only view and submit monthly reports.

**Transport Service Provider Contract Administrator** allows Transport Service Providers to be able to log in and view their contracts, route information, payment history and monthly performance metrics submitted on behalf of their organisation. Access includes view and download payment advice, view contract and route information as well as view and submit monthly reports for the services their organization runs. If a user needs to do everything in Pokapū Waka Kura for their company, then they only need this role.

## **Evidence of Identity (EOI) Information for the Education Sector Logon**

### **EOI Requirements for Authorisers or Delegated Authorisers**

It is the responsibility of the TSP Education Sector Logon Authoriser or Delegated Authoriser to confirm they have sighted the original, or a certified copy (certified by a Justice of the Peace, Doctor, Kaumatua, Minister of Religion), of both of your identification documents prior to signing off your Education Sector User Access Request.

If the EOI documentation presented indicates a name change (e.g. by marriage or deed poll) the applicant should provide a third document from the Name Change Documents section below as certification of the name change. If this documentation is not provided then the name cannot be used in the Education Sector Logon.

### **Evidence of Identity Document Lists**

All ESL users are required to provide two types of Evidence of Identification documentation as outlined below;

- One EOI document to be provided from the Primary Identification Documents listed below
- One EOI document to be provided from the Supporting Identification Documents listed below

#### **Primary Identification documents**

One document from the following:

- Overseas Passport
- Emergency Travel Document (ETD)
- NZ Refugee Travel Document (RTD)
- NZ Certificate of Identity (issued to non-NZ citizens who cannot obtain a passport from their country of origin)
- NZ Certificate of Identity (issued to people who have refugee status)
- NZ Firearms Licence
- NZ Birth Certificate
- NZ Citizenship Certificate

#### **Name Change Documents**

- NZ Marriage Certificate
- NZ Civil Union Certificate
- Change of Name by Deed Poll
- NZ Name Change Certificate
- New Zealand Divorce Papers
- Certificate of Annulment
- Change of Name by Statutory Declaration
