Purpose of Report

The purpose of this paper is for you to:

- Note that the Combined Board for Westbridge Residential School (4157) and Halswell Residential College (522) has an alternative constitution, approved under Section 95 of the Education Act 1989¹, which allows for up to five board members to be appointed by the Minister of Education.
- Note that there are currently five board members appointed by the Minister on the Board, with staggered terms of office. Three board members were appointed with terms of office ending 26 February 2023. The remaining two board members were appointed with terms of office ending on 28 February 2021.
- Note that the Ministry of Education has facilitated the selection process on your behalf, for two board member positions, with a term of office commencing 1 March 2021.
- Note that the Ministry of Education recommends Moses Ma'alo Faleolo and Lorraine Taogaga for appointment, for a period of three years.
- Agree to the proposed appointments;
- If you agree, sign letters to the successful candidates and the current Board Chairperson confirming the appointments;
- Note that the Ministry will notify all unsuccessful candidates;
- Agree this Education Report is proactively released as part of the next publication.

Summary

- 1 Westbridge Residential School (4157) in Auckland and Halswell Residential College (522) in Christchurch are special institutions as stated in Schedule 2 of the Education and Training Act 2020.
- The two schools provide special education within a residential setting for students who need significant curriculum adaptation due to an underlying intellectual impairment and whose education, social, emotional and behavioural needs cannot be met in other educational environments.
- The schools have a Combined Board with an alternative constitution that allows up to five board members to be appointed by the Minister of Education.
- There are currently five board members appointed by the Minister of Education, on the Board. Three board members were appointed with terms of office ending 26 February 2023. The remaining two board members were appointed with terms of office ending on 28 February 2021. The Board wish to continue the staggered appointments to assist with board continuity.
- The Ministry of Education has facilitated the selection process of board members on your behalf.
- A selection panel, comprising three Ministry of Education staff and the President of the New Zealand School Trustees Association (NZSTA), met on 14 and 15 October 2020 to review applications and shortlist the candidates for recommendation.
- The panel recognised the need for the Board to have suitably qualified or experienced members with a range of skills to ensure its ongoing effectiveness. In making recommendations, the panel considered the balance of skills of the board members remaining on the Board alongside the knowledge, experience and perspectives that each prospective candidate would contribute. The panel was committed to recommending candidates who represent gender and ethnic (particularly Māori and Pacific) diversity, so that the Board better reflects the diverse communities it serves.
- The panel recommends two candidates, Moses Ma'alo Faleolo and Lorraine Taogaga for appointment.
- As Minister of Education, you are able to appoint up to two members to the Board at this time. This report recommends the two candidates are appointed for a term of office of three years, from 1 March 2021 to 25 February 2024.

Background

- 1. Westbridge Residential School (4157) in Auckland and Halswell Residential College (522) in Christchurch are special institutions as defined by the Education and Training Act 2020 and stated within Schedule 2².
- 2. Halswell Residential College caters for students with intellectual and/or learning disabilities. Westbridge Residential School has a strong focus on using Restorative Practices as a way of supporting their students to make positive changes in behaviour. Both schools provide special education within a residential setting for students who need significant curriculum adaptation due to an underlying intellectual impairment and whose education, social, emotional and behaviour needs, cannot be met in other educational environments.
- 3. Students are typically enrolled in the schools for 12-18 months during which time their whānau are also supported to make positive changes.
- 4. The changing nature and special characteristics of the student populations of these institutions mean that the schools do not have an enduring parent community. A board that includes elected parent and student representatives is therefore not appropriate.
- 5. In December 2014, the then Minister of Education approved a combined board with an alternative constitution, for Westbridge Residential School (4157) and Halswell Residential College (522) under section 110 and section 95 of the Education Act 1989. The decision establishing a combined board with an alternative constitution was published in the New Zealand Gazette on 9 January 2014 (Notice Number 2014-go208, Page 32, Issue 1), to take effect from 31 January 2014. The alternative constitution provided for the Minister of Education to appoint a chairperson and up to four members.
- 6. In June 2016, the then Minister approved an amendment to the alternative constitution for the Board, and this decision was published in the *New Zealand Gazette* on 23 June 2016 (Notice Number 2016-go3562, Issue Number 58). At this time, the constitution changed to provide for the Minister of Education to appoint up to five members, and removed the ability for the Minister to appoint a Board Chairperson.
- 7. The current constitution of the Board is as follows:
 - up to five members appointed by the Minister of Education as the Minister considers appropriate;
 - the Principal of Westbridge Residential School;
 - the Principal of Halswell Residential College;
 - one staff representative nominated and elected by the staff of the two schools;
 and
 - up to three trustees co-opted by the Board.
- 8. You are not able to delegate the authority to make these appointments, as they are specified in the alternative constitution.
- 9. The Ministry facilitates the process of seeking and evaluating candidates on your behalf and now presents you with recommended candidates for your consideration.

Board membership

- 10. In 2014, the then Minister of Education appointed four members and a Chairperson to the Board, commencing from 31 January 2014. Two of the members were appointed for a term of 11 months, and the other two members and Chairperson were appointed for a term of two and a half years.
- 11. The appointments were staggered to help with the Board's succession planning. It is the Board's wish that this staggered appointment arrangement continues.
- 12. The table below sets out the terms of office for all current Ministerial appointed members to the Board:

- 13. In October 2019, the Ministry of Education identified an inconsistency with the original appointment letters for Elizabeth Waugh and Joanne Walker, who were appointed from February 2018 [METIS 1208150 refers]. The appointment letters stated, "Your appointment is for three years and will end on 31 January 2020", which resulted in these two members being appointed for a truncated term of 23 months, rather than the standard three years.
- 14. At this time, you agreed to re-appoint Elizabeth Waugh and Joanne Walker for a further 13 months from February 2020 to February 2021 which would enable them to serve a total term of three years, as was originally intended [METIS 1208150 refers], and to maintain the staggered appointments.
- 15. These two board members' terms of office will expire on 28 February 2021 and therefore the Ministry of Education is recommending two candidates for your consideration.

The Selection Process

The Ministry sought expressions of interest from people wishing to be considered for a role as a Board member appointed by the Minister of Education, to the Combined Board for Westbridge Residential School and Halswell Residential College. We placed advertisements on several online job platforms³. The Nominations Services for the Ministry for Women, Ministry for Pacific Peoples and Te Puni Kōkiri - Ministry of Māori Development were approached to present suitable candidates, and the details were also distributed to the Disabled People's Organisations Coalition.

- 17. Applications were open from Monday 7 September 2020 to Sunday 5 October 2020. Fourteen completed applications were received by the closing date. Summary biographical information about each candidate is provided in Annex 1.
- 18. All candidates who submitted applications were required to complete a declaration stating that they were eligible to become a board member with regard to the ineligibility criteria specified in Clause 9 and 10 of Schedule 23 to the Education and Training Act 2020. The candidates were also required to declare any conflicts of interest.
- 19. A selection panel, comprising three Ministry of Education staff and the President of the New Zealand School Trustees Association (NZSTA), met on 14 and 15 October 2020 to review applications and shortlist the candidates for recommendation. Panel members were provided with candidate documentation Curricula Vitae (CV), cover letters, and any accompanying attachments.

- 20. During this meeting, and prior to commencing shortlisting, the panel discussed any potential conflicts of interest in assessing the candidates. The following were identified:
 - Sally Jackson declared a possible conflict of interest with Joanne Walker as she knows Joanne through previous work together as well as in a personal capacity.
 - Sue Barr declared a possible conflict of interest with Ruth Gorinksi, who worked as a Student Achievement Function Practitioner at the Ministry of Education in 2013/2014.
 - Lorraine Kerr declared a possible conflict of interest with Latham Martin who
 is currently the regional Chair for NZSTA (West Coast) and Joycelyn Tauevihi,
 who is currently on the Board of NZSTA.
 - Deidre Alderson declared a possible perceived conflict of interest as she
 was interviewed as part of an investigation, following a complaint made by the
 Chairperson of the Combined Board of Westbridge Residential School and
 Halswell Residential College against another Ministry staff member. No
 conflicts were declared with any of the candidates.
- 21. The panel decided that the knowledge the members had of the four candidates in a professional capacity did not preclude them from participating on the panel, but the respective panel members who had declared conflicts limited their involvement in the discussions and assessment of the respective candidates. It was also determined that the previous interactions between the Board Chairperson and Deidre Alderson should not prevent her involvement in the panel as the complaint from the Board Chairperson was not against her, the panel were not recommending candidates for the Chairperson role, nor is the Board Chairperson a candidate for consideration.

- 22. The panel reviewed candidates for the two upcoming board positions, on the basis of maintaining a broad range of skills and experience as well as ethnic and gender diversity. The panel also assessed the knowledge and experience of the three continuing Board members to identify gaps in knowledge and experience. The panel looked for complementary experience and knowledge to ensure diversity on the Board, rather than a traditional-matrix based approach, which assigned weights to particular skills and experience.
- 23. The panel also considered feedback from the Board Chairperson and Principals of both schools regarding skills and knowledge that they believed would be beneficial to the Board. This feedback included a request to consider candidates with a professional background or understanding of mental health and/or trauma and trauma informed care; and consideration of candidates of Pacific ethnicity given the proportion of Pacific students at the schools.
- 24. The key criteria used to evaluate the knowledge and experience of each of the candidates are listed below:
 - Whether the candidate has experience in governance (school governance, or other public sector/not-for-profit sectors);
 - Whether the candidate's application demonstrates an interest / experience / understanding of schools' purpose, vision, values and/or student community;
 - Whether the candidate's application demonstrates an understanding / experience / interest of/in Ministry of Education priority groups of students;
 - Whether the candidate's application demonstrated/indicated cultural awareness or experience in culturally responsive practices (Māori and/or Pacific)?
 - Noting candidate's other relevant knowledge / experience.
- 25. The panel evaluated the experience of each candidate and discussed key knowledge areas that would be beneficial to the overall board composition and what experience could be beneficial to the Board within its next term. The assessment discussions were undertaken in an iterative and collaborative way, until the panel reached a consensus. This process is summarised in a table in Annex 1b.
- The Ministry conducted reference checks for the three shortlisted candidates. All reference checks were satisfactory and did not highlight any concerns. Additional checks were undertaken to try to verify candidates' qualifications where possible. Social media and Google searches were undertaken to identify any controversial information online associated with the three shortlisted candidates. No associated information was identified with the three shortlisted candidates.

Recommended appointments

27. The panel recognised the need for the Board to have suitably qualified or experienced people with a range of skills to ensure its ongoing effectiveness. Given the small number of positions available, the panel wanted to ensure that the recommended candidates provided a variety of complementary knowledge and experience to the Board.

- 28. The panel considered the balance of skills, knowledge, experience and perspectives that each candidate would contribute, so that the Board better reflects the diverse communities it serves. The panel also considered the experience and knowledge of the three Board members who would continue in office until 2023. This was so that the panel could evaluate the candidates' experience and knowledge alongside those of the continuing board members, so that the Board would have a broad range of knowledge and experience.
- 29. The panel was particularly committed to try to secure Māori/ Pacific representation on the Board, but at the same time ensuring that each candidate had the right and strong skills to benefit the Board. Given the disproportionate number of Māori students enrolled at the schools the panel felt strongly about increasing representation on the Board.
- 30. The three candidates who ranked the highest in terms of relevant skills, experience and knowledge, would also improve the cultural diversity of the Board. All three of the top ranked candidates were of either Māori or Pacific cultural heritage.
- 31. The panel recommends two candidates for appointment Moses Ma'alo Faleolo and Lorraine Taogaga. The Curricula Vitae for these two candidates are available in Annex 1a.
- 32. Together, these two candidates bring their diverse experience, background and knowledge in school governance, governance of a special school, social work, youth justice, at-risk learners, education, policy development, culturally responsive teaching practices (Māori and Pacific) and a passion for equity in and accessibility to education. Both candidates bring understanding and commitment to priority groups particularly Māori and Pacific students, as well students with high or complex learning needs.
- 33. In the opinion of the panel, these candidates bring experience and knowledge that would be of most benefit to the Board over the next three years.
- 34. The table below lists the candidates who submitted completed applications through the Ministry of Education's online Careers Centre, which were then considered by the panel.

Co-optation recommendations

- 35. The panel discussed ways of how other diverse perspectives could be represented on the Board, or included in decision-making, to reflect the diverse community the Board serves. This includes encouraging the Board, through co-optation or other means, to consider the voice of younger people or former students, people with neurodiversity, members of the rainbow community and/or those who identify as gender diverse.
- 36. We have included the recommendation for co-optation considerations in the letter to the Board Chairperson, David Turnbull.

Risk and Mitigation

- 37. If you agree to appoint the recommended candidates, there is a risk that Joanne Walker, the current Board member who applied to be re-appointed but was unsuccessful, may be disappointed and find public avenues to express this disappointment.
- 38. This risk can be mitigated by emphasizing that a robust evaluation process was followed when making recommendations, for your consideration. In particular, the need for the Board to have a balance of skills and knowledge as well as ethnic representation as there are currently no Māori or Pacific members on the Board.

Next Steps

- 39. Letters to the successful candidates are provided for your signature (see Annex 2).
- 40. A letter to the Board Chairperson, confirming the appointments is also provided for your signature (Annex 3).
- 41. We have also included letters to Joanne Walker (current trustee who has not been recommended for reappointment) and to Elizabeth Waugh (current trustee who did not reapply) thanking them for their contribution to the Board during their tenure. These are included in Annex 4 and Annex 5 respectively.
- 42. The Ministry will write to all other unsuccessful candidates and thank them for their interest.

Proactive Release

43. It is intended that this Education Report be proactively released as per your expectation that information be released as soon as possible. Any information that may need to be withheld will be done so in line with the provisions of the Official Information Act 1982.

Moses Ma'alo Faleolo



While I have every confidence in the skills of the members appointed, I would like the Board to consider how other diverse perspectives could be represented on the Board or included in decision making, to reflect the diverse community the Board serves. This could include, through co-optation or other means, considering the voice of younger people or former students, people with neurodiversity, members of the rainbow community and/or those who identify as gender diverse.

I also recommend that the Board continue work with the Ministry's Auckland and Christchurch offices and the New Zealand School Trustees Association (NZSTA) to ensure that Board members are aware of their responsibilities to declare any conflicts of interest to the Ministry and to withdraw from related discussions and decision-making when necessary. This will ensure that any potential conflicts of interest continue to be well managed.

I congratulate the new appointees and wish the Board all the best.
