Purpose

- 1. The purpose of this report is for you to sign and send a letter to the Regulations Review Committee (the Committee) to consult it on the draft replacement Code and related consultation material.
- In 2020 and 2021, you corresponded with the Committee about the Education (Pastoral Care of Domestic Tertiary Students) Interim Code of Practice 2019 (the Interim Code) [METIS 1245064, 1249916 and 1252531 refer]. In response to its concerns, you made minor and technical changes to the Interim Code which were presented to the House and made public on 31 March 2021 [METIS 1252531 refers].
- 3. You also informed the Committee that you would consult it on a draft replacement Code once it was prepared [METIS 1245064 refers]. Under Standing Order 326(2), a Minister may refer draft regulations to the Committee for consideration and the Committee may report on the draft regulations to the Minister.

Dear Chair,

In 2020 and 2021, I corresponded with the Chair of the Committee about the Education (Pastoral Care of Domestic Tertiary Students) Interim Code of Practice 2019 (the Interim Code). In response to concerns raised by the Committee, I made minor and technical changes to the Interim Code which took effect from 31 March 2021.

The Interim Code will be replaced by an ongoing Code by 1 January 2022. In earlier correspondence, I indicated that during the development of the replacement Code, officials will undertake work to ensure that:

- the empowering provisions are fit for purpose;
- the replacement Code better delivers the outcomes sought; and
- the processes that the code administrator will use are adequately supported in legislation and regulation.

The development of the replacement Code will also take account of any recommendations resulting from the Inquiry into Student Accommodation that was launched by the Education and Workforce Select Committee in 2020.

I previously indicated that the Committee would be consulted on a draft replacement Code once it was prepared. The Ministry of Education has opened formal public consultation on the draft replacement Code for all tertiary and international learners, a new dispute resolution scheme for domestic tertiary learners, and proposed law changes to support learner wellbeing and safety. The consultation is open from 7 April until 21 May 2021. I welcome any written feedback from the Committee on the draft replacement Code and wider consultation material.
