Purpose of Report

This report seeks your approval for a change in designation for He Puna Ruku Mātauranga o Whangaruru (1667), from a state school without a specific designation to a Year 1-8, coeducational designated character school (kura-ā-iwi), under section 200(1)(a) of the Education and Training Act 2020 (the Act).

In 2021, Minister Hipkins approved consultation on this proposal [METIS 1272330], and the consultation has now been completed.

Summary

- 1. He Puna Ruku Mātauranga o Whangaruru (previously known as Whangaruru School) is a state co-educational, decile 1, Year 1-8 primary school in a rural area south of Russell in the Bay of Islands. All ākonga, some members of staff and the school Board are associated with the sub-tribes of the Ngāti Wai iwi.
- 2. In the first half of 2019 the Board carried out consultation with its community and respective tribal entities for a proposal to apply for membership with Ngā Kura a lwi o Aotearoa (NKAI). Among the requirements for membership with NKAI, is initiating a four-year transition plan to operate at Level 1 of Māori Language Resourcing (MLR) funding.

- 3. In mid-2019 the Board applied for membership with NKAI and was informed it had gained provisional approval later that year.
- 4. The Board now seeks a change of designation to a designated character school (kura-ā-iwi) under section 200(1)(a) of the Education and Training Act 2020.
- 5. Approving this proposal will support Maihi Karauna, the Māori language strategy and foster increased participation and success for Māori ākonga through the advancement of Māori education initiatives. It also aligns with Ka Hikitia and the National Education Network Plan (NENP) to support Māori Medium Education in the schooling network.
- 6. If you agree to the proposed change of designation, we recommend the change takes effect from Term 4, 17 October 2022.

The Ministry recommends that you:

- a. note that He Puna Ruku Mātauranga o Whangaruru is a state school that has been accepted for membership to Ngā Kura a Iwi o Aotearoa and has applied to be designated as a designated character school (kura-ā-iwi);
- b. **note** that the Ministry has completed consultation about the possible change in designation of He Puna Ruku Mātauranga o Whangaruru as a designated character school, and no objections have been raised;
- c. **agree** that the proposed designation of the kura meets the requirements in section 204(3) of the Education and Training Act 2020; and

d. **agree** to change the designation of He Puna Ruku Mātauranga o Whangaruru under section 200(1)(a) of the Education and Training Act 2020, to take effect from the start of Term 4, 17 October 2022.

Background

- 1. He Puna Ruku Mātauranga o Whangaruru is a state co-educational, decile 1, Year 1-8 primary school in a rural area south of Russell in the Bay of Islands. All members of the Board and most staff are associated with the Ngāti Wai based sub-tribes of Whangaruru.
- 2. Following the opening of the school in 2005 with a roll of 82, there was a significant drop to 30 ākonga in 2014. The roll then grew to 56 in 2020 and has since dropped again to 50 ākonga as of July 2022. Historically between 80% and 100% of ākonga have been of Māori descent.
- 3. In 2016, consultation with whānau captured a strong demand for provision of learning experiences in "te reo Māori and tikanga of Ngāti Wai". The Board responded by setting into its strategic plan an initial 2017-2018 timeline to initiate developing te reo Māori immersion provision. The Board then set itself to investigate te reo Māori immersion models.
- 4. In 2017, consultation with the school community established there was a demand for more te reo Māori and tikanga Māori in the kura. That initial demand expanded to include Ngāti Wai heritage, environments, history, narratives, customs, and practices.
- 5. In 2018, the Board and Tumuaki committed to developing a localised curriculum and support systems for staff and whānau to begin developing their cultural capability and capacity.
- 6. In the first half of 2019, the Board carried out further consultation with its whānau, community and respective tribal entities for a proposal to apply for membership with Ngā Kura ā lwi o Aotearoa (NKAI). Consultation included a presentation from NKAI on its model.
- 7. The Board gained considerable support from its whānau, community, hapū and iwi, including its tribal trust board and education unit to apply for membership with NKAI.
- 8. By the close of 2019, NKAI granted provisional approval for Whangaruru School's application, before full approval was given by the close of 2020. NKAI committed to actively support a kura-ā-iwi designated character school, should this be approved.

Process for the proposed change

- 9. Under section 200(1)(a) of the Act, a state school that is not a designated character school can be designated as a designated character school by notice in the *New Zealand Gazette*, following consultation with the school's board. Under section 209(2)(g) of the Act you must first consult with the boards of all state schools whose rolls might, in your opinion, be affected if this proposal is approved. The Ministry has undertaken the required consultation on your behalf and there have been no objections raised.
- 10. For you to designate a school as a designated character school, the school must meet the requirements in section 204(3) of the Act. These are the same as for establishing a new designated character school. The three key requirements that apply are:
 - a. the school will have a character that is in some way specific or different from the character of ordinary state schools, and
 - b. it is desirable for students whose parents want them to do so to get such an education, and

- c. students will receive an education that differs significantly from the education they would receive at an ordinary state school.
- 11. If you agree to designation of the kura, the Secretary for Education must set a maximum roll for the school. This is required by section 204(7) of the Act. We propose the maximum roll be set at 75 students.

Consultation

- 12. Section 209 of the Act requires the Minister of Education to consult the boards of all state schools whose rolls might be affected before deciding whether to change the designation of an existing state school.
- 13. The Ministry has consulted with the boards of Hikurangi School (35.3km southwest), Te Kura o Waikare (37.2km northwest), Russell School (43.7km drive northwest), Karetū School (48.5km drive northwest), Maromākū School (51.9km drive west), and Pāihia School (67km drive northwest).
- 14. Te Kura o Waikare located 37.2km northwest, is the sole dedicated Māori medium kura among the schools consulted, they are also a member of NKAI. The response received from Te Kura o Waikare expressed full support for the change of designation.
- 15. None of the other schools consulted provided any comments.

The proposed designated character

- 16. For you to designate a school as a designated character school, the school must meet the requirements in section 204(3) of the Act. These are the same as for establishing a new designated character school. The three key requirements that apply are:
 - a. the school will have a character that is in some way specific or different from the character of ordinary state schools, and
 - b. it is desirable for students whose parents want them to do so to get such an education, and
 - c. students will receive an education that differs significantly from the education they would receive at an ordinary state school.
- 17. The proposed designated character includes a tailored approach to teaching and learning. This is detailed in the application as follows:
 - He Puna Ruku Mātauranga o Whangaruru would integrate Māori Medium Education into all aspects of the school in the local dialect.
 - He Puna Ruku Mātauranga o Whangaruru will ensure that, alongside Te Marautanga o Aotearoa, it will operate in accordance with the cultural practices of the hapū and iwi of Ngāti Wai.
 - The He Puna Ruku Mātauranga o Whangaruru curriculum would specifically reflect the mātauranga and tikanga of the tangata whenua of the hapū and iwi of Ngāti Wai. This fits within the Ka Hikitia education strategy for Māori to achieve education success as Māori.

- 18. The designated character meets the legislative criteria for being different from a mainstream state school. The character will deliver on the identity, language and culture demand by integrating them in all aspects of the operation of the school, and working with the hapū and iwi of Ngāti Wai.
- 19. The Ministry considers that the application has detailed that:
 - a) the designated character school will have a character that is different from mainstream state schools, in that the kura-ā-iwi model is already established as having such character
 - b) it is desirable for students whose parents wish them to get such an education, as it fits within the Ka Hikitia education strategy for Māori to achieve education success as Māori
 - c) the kura-ā-iwi model provides education of a kind that differs significantly from the education students would receive at an ordinary state school
 - d) the Whangaruru curriculum would specifically reflect the mātauranga and tikanga of the tangata whenua of the hapū and iwi of Ngāti Wai.
- 20. Approving this proposal will support Maihi Karauna, the Māori language strategy and foster increased participation and success for Māori students through the advancement of Māori education initiatives. It also aligns with Ka Hikitia and the Te Tai Tokerau network plan to support Māori Medium Education in the schooling network.

Education at the Kura

21. The Education Review Office (ERO) last reviewed the school in February 2019. The report states:

"There has been a dedicated approach to the implementation of Te Marautanga o Aotearoa (TMoA). The school's curriculum design is responsive to the aspirations of students, whānau, hapū and iwi. Together they have identified authentic and meaningful contexts for learning, and the environmental conditions required for children to learn."

"Teachers have undertaken effective professional learning about teaching and assessment practices. They have implemented new assessment tools. These continue to be further modified to support the implementation of TMoA and to help teachers provide positive outcomes for children."

"Most students in the school have had less than two years in total immersion learning. Their achievement outcomes progress steadily during their time in this setting. Appropriate systems are in place for data management. The principal analyses student achievement well to identify next steps to support learning progress."

"The board and staff have implemented a strategic approach to ongoing improvements. Good internal evaluation processes are in place to guide strategic development. The implementation of TMoA has been evaluated and this process is ongoing."

22. The kura was on a three year ERO review cycle and is now on Te Ara Huarau, ERO's review cycle.

Network considerations

- 23. He Puna Ruku Mātauranga o Whangaruru is not part of the local Peowhairangi Kāhui
- 24. The Minstry considers the proposed change in designation for He Puna Ruku Mātauranga o Whangaruru would have a minimal effect on the schooling network.
- 25. Te Kura o Waikare, the other designated character school in the area, is a coeducational composite Year 1-10 kura, situated 37.2km northwest of He Puna Ruku Mātauranga o Whangaruru. Te Kura o Waikare had a March 2022 roll of 90 students. Whangaruru has kept Te Kura o Waikare fully aware of their intention to seek permission to transition to operate as a full te reo Māori immersion school. Waikare has assisted the kura throught the process.
- 26. Whangārei is the nearest town centre to the Whangaruru community, situated 51.1km to the south. There are a number of primary, intermediate and secondary schools in Whangārei, but it is unlikely any would be affected by this proposed change for Whangaruru.

Property

- 27. If this proposed change is approved, there would be no immediate change in property requirements at the kura. The change of teaching ratios associated with transitioning to Māori Medium Education means that the four exisiting teaching spaces on site will be utilised, whereas prior to this, there were intentions to demolish a classroom that was not required. It is anticipated that at least one of the existing classrooms will require refurbishment to improve its condition.
- 28. He Puna Ruku Mātauranga o Whangaruru has indicated that at some time in the future the Board will apply for a change of classification from operating as a Year 1-8 full primary school to become a Year 1-10 composite school. The property implications for this would be considered at the time of a future application.
- 29. While operating as an English medium school, the teacher/student ratio determines a capacity for 100 students in the current teaching spaces. As the kura progresses a transition to operate as Māori medium kura, the teacher/ākonga ratio will reduce capacity to 72 ākonga, meaning if the roll was to exceed 72, and be growing the kura will be entitled to additional teaching spaces.
- 30. It is proposed that the maximum roll be set at 75 ākonga so that any future roll growth requirements are aligned with reviewing the maximum roll.

Financial Implications

- 31. The only change in resourcing is Māori Language Resourcing (MLR) funding.
- 32. Currently He Puna Ruku Mātauranga o Whangaruru is in the final year of a four-year staggered transition to operate fully at Level 1 MLR. Its 2020 Year 1-3 cohort was the

- first to be moved to Level 1 now generating \$38,336. The remainder of the classes sit across Levels 2-4 generating respectively \$1,169, \$2,836, and \$995.
- 33. Based on the current roll of 50 ākonga, the projected MLR Level 1 funding would increase to \$58,956.03 (GST incl.) this year. In 2023, the projected MLR funding would then be \$90,560.20 following a Budget 22 initiative to increase MLR Level 1 funding to support Māori language education provision and growth.

Transport

- 34. He Puna Ruku Mātauranga o Whangaruru is entitled to apply for school transport assistance (STA) in the form of a Daily Bus Service or Conveyance Allowance. The kura currently does not receive any STA from the Ministry. A change in designation would not change the school's entitlement to apply for STA under the Māori Medium School (MMS) service agreement.
- 35. A change in designation entitles He Puna Ruku Mātauranga o Whangaruru to the School Transports' MMS service agreement transport funding. The per-student rate is \$9.34 plus \$3.35 per student per quarter admin rate for a rural based decile 1 school. Eligibility for this funding is based on the criteria for the distance to school.
- 36. Using school data from the 2021 July roll return, under MMS an estimated school transport assistance funding for He Puna Ruku Mātauranga o Whangaruru is calculated at \$17,109 per quarter. This funding is currently calculated based on the number of eligible ākonga attending the kura, the decile level, and the per-student rate as noted above. The funding figure is an estimation and subject to change.

Staffing implications

37. The change of designation would not have any staffing impact.

Risks

38. Including the responses received from consultation, we have not identified any risks associated with this proposal.

Conclusion

- 39. The Ministry's recommendation is that you approve the change in designation for He Puna Ruku Mātauranga o Whangaruru because:
 - the board completed due diligence following community consultation that captured a demand for provision of learning experiences in "te reo Māori and tikanga of Ngāti Wai", "Ngāti Wai heritage, environments, history, narratives, customs and practices". This included:
 - holding discussions on Māori medium models and possible peak body membership
 - completing a process of application, approval, and induction with NKAI

- including into its strategic plan the development of te reo Māori immersion provision
- the development of a localised curriculum and support systems for staff and whānau to begin developing their cultural capability and capacity
- the initiation of a staggered transition from English medium to te reo Māori medium provision.
- alongside Te Marautanga o Aotearoa, it is intended the localised curriculum that will be developed in association with hapū and the iwi Ngāti Wai, will strengthen the delivery on identity, language and culture demand which is becoming increasingly common across Māori communities of the Tai Tokerau region
- as a kura-ā-iwi, He Puna Ruku Mātauranga o Whangaruru would have the support of NKAI
- the consultation carried out by the Ministry indicated that those consulted were positive about the change
- approving this proposal will support Maihi Karauna, the Māori language strategy and foster increased participation and success for Māori ākonga through the advancement of Māori education initiatives. It also aligns with Ka Hikitia and the National Education Network Plan to support Māori Medium Education in the schooling network.

Next Steps

- 40. If you agree to the change of designation, please sign the notice for the *New Zealand Gazette* (Annex 1), the letters to the board (Annex 2) and local Members of Parliament (Annex 3).
- 41. The Secretary will set a maximum roll for the school as required by section 204(7) of the Act.

Under sections 200, 204 and 205 of the Education and Training Act 2020 (the Act), I hereby designate He Puna Ruku Mātauranga o Whangaruru, Russell, Bay of Islands, as a designated character school. This designation will take effect from 17 October 2022.

He Puna Ruku Mātauranga o Whangaruru will operate in accordance with section 204 of the Education and Training Act 2020. The designated character of the school will be recorded as:

He Puna Ruku Mātauranga o Whangaruru will function, operate and frame its curriculum within its primary Punaruku identity centred within the worldview of its Whangaruru based marae and hapū of Ngāti Wai, and further by its wider Ngāti Wai and Tai Tokerau tribal kinship.

The constitution of the He Puna Ruku Mātauranga o Whangaruru School Board shall not be changed by this notice.
