Purpose of Report

The purpose of this paper is to update you, as requested by your office, on the Attendance Service (AS) contract renewal process, including progress of the initial re-design trials.

It includes the status of all AS contracts currently being renewed, indicative dates around start and end dates of these contracts, and their coverage areas.

Background

- Since 2013, the Ministry has had 22 contracts for the Attendance Service (AS), including a mixture of lwi, non-government organisations (NGOs) and nine schools. Twenty of those contracts expire in December 2021, with the remaining two ending in December 2022.
- In 2019, the former Associate Minister of Education initiated a re-design of the AS. The aim was to explore a new model of attendance management, including gathering local knowledge of what works in schools and communities and placing resources closer to schools.
- The re-design is being undertaken in two phases. It is also taking into consideration the establishment of Te Mahau within a re-designed Te Tāhuhu o te Mātauranga | Ministry of Education.

Phase One


- In 2020, trials of the re-design started in Kawerau and South Auckland B which covers Manurewa, Howick, Papakura, Franklin and North Waikato.
- In 2020, the Ministry also consulted with schools, current AS providers and lwi to codesign the future delivery of the service. This included consideration of who could provide the service in each community and what sort of service was needed.
- As a result of COVID-19, regions were not able to determine their proposed long-term approach and the evaluations of the trials at Kawerau and South Auckland B were delayed. Consequently, contracts were extended by one year, to expire in December 2022. These extensions were to allow the Ministry sufficient time to determine a long-term approach for the AS (Phase 2).
- As a result of our consultations in 2022 the AS will be provided through 45 contracts 24 schools, nine lwi/Māori organisations, nine NGOs and three are still to be determined. This is already starting to make the shift to having the service closer to schools. All contracts end in December 2022.
- A table outlining contracts in 2021 and 2022, including service regions, is attached as Appendix 1.

Phase Two

- In 2022, the Ministry will continue the AS re-design to confirm the long-term approach for all regions. The re-design will consider the following:
 - Evaluation findings from the trials. The evaluation is due to be completed in February with a final report in April 2022.
 - Recommendations from the Select Committee Inquiry into Attendance.
 - Early learnings from 2022 contracts.
 - Further consultation in the regions, including with lwi.
- This work closely aligns with Priority 6 of the Learning Support Action Plan. Priority 6 outlines the importance of improving education for children and young people at-risk of disengaging. Priority 6 provides the broad umbrella for work to better support children and young people to stay engaged in their learning through the re-design of the AS.

Attendance Service Trial Update

- In 2020, the Ministry took the opportunity to trial new ways of working in Kawerau and South Auckland B. The Ministry worked with local schools to co-design and test approaches based on local knowledge of what works best to support ākonga attendance in each community.
- Before these trials began in 2020 all providers delivered both the unjustified absence and the non-enrolled streams of the AS (an integrated service). In Kawerau, Tarawera High School is contracted to provide an integrated AS that encourages a community-wide approach to attendance issues.
- 13 In the South Auckland B service area, the service has been split into two work streams:
 - One for students who are enrolled in school but are unjustifiably absent with five lead schools employing attendance advisers who are responsible for managing this work for schools in their cluster.
 - The other is for students who are not enrolled at school, managed by an external provider who is based in the local community.





Evaluation of the trials

The trial evaluation has been delayed by Covid-19. The evaluation is due to be completed in February with a final report in April 2022.
