



Briefing Note: Progress update on Coal Boiler Replacement Programme

Purpose of Report

This briefing note provides you with an updated map of confirmed coal boilers for replacement. It also provides you with an update on the progress of the Ministry of Education-led coal boiler replacement programme, using funding from the State Sector Decarbonisation Fund.

Summary

- In March 2020, the Ministry provided you with a map of confirmed coal boiler replacements, funded through the State Sector Decarbonisation Fund (the Fund).
- To date, the Ministry has been allocated \$54.84m from the Fund to remove up to 90 coal boilers from state schools.
- 36 schools have now been confirmed to receive coal boiler replacements. A total of 39 boilers will be replaced at these schools as two of the schools have multiple boilers.
- Of the 36 schools confirmed to date, 26 were announced during 2020, as part of funding allocated through Tranche One and Tranche Three of the Fund. An additional 10 schools with coal boiler replacements will be announced by the Minister for Climate Change in coming weeks, as part of funding for Tranche Four of the Fund.
- The Ministry is progressing with delivery, planning and procurement for boiler replacements through the Ministry-led Coal Boiler Replacement Programme.

Background

- 1. The Ministry has been allocated \$54.84m in funding through the State Sector Decarbonisation Fund (the Fund) to replace up to 90 coal boilers at schools with a remaining useful life of less than five years. This funding is being allocated to school projects and announced by the Minister for Climate Change through a series of tranches.
- 2. In January 2020, the Minister for Climate Change announced the first eight schools that would receive 11 coal boiler replacements through Tranche One of the Fund (METIS 1218022 refers). A further 18 schools were announced in August 2020 as part of projects funded from Tranche Three (METIS 1236433 refers). Tranche two was largely focussed on boiler replacements and vehicle fleet upgrades across government.
- 3. Since this funding was allocated, the Ministry's School Coal Boiler Replacement Programme has progressed with planning and procurement for the centrally led delivery of coal boiler replacements throughout the country.

Progress of Ministry's Coal Boiler Replacement Programme

- 4. The programme is currently running to schedule and we expect further tranches of schools to be announced over coming months. We have been working with the Energy Efficiency and Conservation Authority (EECA) to complete heating reports for each of the 36 schools that have so far been confirmed for coal boiler replacement, and data has now been collected from each of these schools. These heating reports provide information and advice on the best solution for replacement at each school (e.g. heat pumps, electric or biomass boilers). We expect that on-site heating assessments for the replacement of all 90 boilers will be complete by the end of the year.
- 5. The procurement of replacement boiler systems is currently under way. We have commenced the tender process to set up a supplier panel for heating solutions, that will ensure value for money and optimise delivery timeframes. Projects are being phased over a three-year programme timeframe and we expect delivery of the programme to accelerate as we commence replacement of heating solutions on a larger scale. To date, two boiler replacement projects have been completed both are from Tranche One. We expect that all projects announced in Tranches One and Three will be completed by the end of 2021.

Communications material and upcoming announcement

6. In March 2020, we provided you with a map of proposed coal boilers initiatives and other Ministry initiatives (METIS 1220552 refers). An updated map of confirmed coal boiler replacements by region, reflecting these additional schools, can be found in Annex One. This map also outlines other Ministry initiatives, including School Investment Package funding received and the number of Sustainability Contestable fund projects per region.

7. Further to the 26 schools announced in 2020, 10 schools will be announced by the Minister for Climate Change as part of funding for Tranche Four of the Fund in the coming weeks. The table over the page lays out the 10 schools that will be included in the upcoming announcement.
