Summary

- Following your meeting with international education sector peak bodies on 11 May 2021, you asked for an opportunity for you to speak to a wider sector group to set out your priorities for international education.
- You will address an audience of approximately 175 sector and government representatives (130 in person and 45 online).
- This is an opportunity for you to update them on the border situation, set out your vision of a smaller, higher-value sector, signal some of your priority work streams, and announce consultation on a draft Policy Statement on Value in International Education.

Background

- 1. You met with international education sector peak bodies on 11 May 2021 to respond to concerns they raised through workshops held by Education New Zealand and the Ministry of Education focussed on the recovery of the sector. You followed up this meeting with a letter to the sector setting out your priorities for international education.
- 2. Following the 11 May meeting, you also requested an opportunity to address a wider sector audience. This forum provides you with the opportunity to:
 - personally express support for the recovery and rebuild of the international education sector to a wide audience
 - repeat some of the messaging you have already delivered, setting the desired direction for the sector
 - update the sector on border developments and related government decisions
 - answer any questions
 - announce upcoming consultation on a draft policy statement on value in international education
- 3. A list of invitees was developed with your office that includes peak body representatives and other sector leaders and practitioners. A number of officials from across international education agencies will also be in attendance to demonstrate a joined up approach, to answer questions during the formal portion of the meeting, and to interact informally with the sector both before (lunch) and after (afternoon tea) the meeting.
- 4. The peak body representatives among the sector attendees have heard your vision for international education and are familiar with details of the border management and how it will continue to impact international education. Other sector attendees will be less aware of these issues. You may receive questions from a wide variety of angles reflecting varying levels of understanding.

- 11. As COVID-19 has impacted education sectors quite differently, it is a challenge to find unified messaging to speak to them together. Proposed answers to questions in the attached Q&A have been formulated with a mixed sector audience in mind.
- 12. While we expect the meeting to have a positive, hopeful tone, the global situation suggests that there is continued waiting and frustration ahead. It may be helpful to accept that there will be "down" moments in the meeting.

Afiqah Ramizi National President, New Zealand International Students Association

Biography

Afiqah is a fourth-year medical student from Malaysia, studying at the University of Auckland. She was elected National President of the New Zealand International Students Association in 2020. In 2019, Afiqah was the International Students' Officer of Auckland University Students' Association (AUSA) and a member of NZISA Rep. Council. Afiqah has said that over the course of several years studying in Auckland, she has realised it is never easy being an international student: "Every year international students are faced with new challenges affected by an international education sector that is rapidly progressing." Afiqah aims to help ease the stages for international students to survive in this country, supported by a committed team of council members consisting of locally elected international student leaders.

Professor Jan Thomas commenced as Vice Chancellor of Massey University in January 2017. From 2012, Jan served as Vice-Chancellor and President at the University of Southern Queensland in Australia, following various senior executive positions at Murdoch University and the University of Notre Dame Australia. Professor Thomas has a PhD in Veterinary Science from Murdoch University and is a Fellow of the Australian Institute for Company Directors. She has received numerous awards for her leadership in education. Professor Thomas is the Chair of Universities New Zealand, Chair of the Quality Assurance Council, and a member of the University Grants Committee.



Stephen Town Chief Executive, Te Pūkenga

Stephen Town was appointed Chief Executive of the newly formed New Zealand Institute of Skills and Technology in 2020. He is a former Chief Executive of Auckland Council, and has held executive positions for over 20 years in tertiary education, local government, and transport.
