#### Purpose of Report

This paper provides you with material to support you at your meeting with early childhood education (ECE) sector leaders on Friday 28 July 2023 to discuss matters relating to a review of ECE funding.

#### Summary

- 1. You have requested that the Ministry of Education convene a workshop with members of the Early Childhood Advisory Committee (ECAC) to consider what a review of the ECE funding model might look like and the impact this might have on ECE work programmes.
- 2. The workshop will run from 9.00am-3.00pm on 28 July 2023. The venue is Te Wāhanga Atawhai Mercy Conference Centre, 15 Guildford Tce, Thorndon, Wellington.

#### Background

- 1. In response to feedback on the recent pay parity funding review and the extension of 20 Hours ECE to two-year-olds, you have asked us to convene a workshop for ECAC members to discuss the possibility of a wider review of ECE funding settings.
- The purpose of this workshop is to provide an opportunity for sector representatives to share their thoughts on the scope and process for a first principles review of the ECE funding model.
- 3. The workshop will also examine the timelines that might apply and the impact such a review might have on the sequencing of other parts of the ECE work programme.
- 4. Following the workshop, the Ministry will provide you with further advice, and include a summary of the views expressed by the representatives. We propose that the attendees will have the opportunity to review the workshop summary before it is sent to your office.

#### The workshop

- 5. The Agenda for the workshop is attached as Annex 1.
- 6. The first part of the day will be devoted to delegates sharing their views. Three focusing questions have been provided in advance, to help facilitate productive conversations in this part of the workshop. These questions are:
  - (a) What should the goal(s) of a funding review be? (i.e., what should it aim to achieve?)
  - (b) What are the core principles of a funding system we would want to consider as part of a first principles review? What should be in or out of scope?
  - (c) What would a good review process look like? How would we ensure that all voices are heard?
- 7. The intention for these sessions is for the Ministry to listen, and gather information on what is important to sector groups in terms of the goals, principles, scope and ideal process for a funding review. We want to ensure that all parties are able to share their views and have these reflected in the summary of the day.
- 8. In the afternoon sessions, the Ministry will share some of the practical considerations around different approaches to a review. This will include information on the Government processes that would need to be worked through, and their implications. Sharing high level details around workstreams, timelines and costings from previous reviews and other relevant consultations will support these conversations.
- 9. We will also work through the potential impact on other work programmes that may need to be delayed, separated out, or integrated into any funding review and record the group's views on the risks and trade-offs associated with the various scenarios.

#### The attendees

10. Members of ECAC were invited to attend this workshop, or to send a delegate in their place. As at 20 July, seventeen organisations have confirmed they are sending representatives. A list of participants is included as Annex 2.

- 11. The day will be facilitated by Nancy Bell, Hautū Deputy Secretary, Te Tai Runga. Andy Jackson, Hautū Deputy Secretary, Te Pou Kaupapahere, and John Brooker, General Manager ECE and System Policy, Te Pou Kaupapahere will also lead sessions.
- 12. Support for table discussions, note taking and the broader secretariat function, will be provided by members of the Ministry's ECE teams.

#### Your role

- 13. You are scheduled to attend the workshop from 9.15am-9.45am. We would like you to provide the opening address and set your expectations for the workshop with those present. Some suggested talking points are included as Annex 3.
- 14. We recommend some time be left open for you to receive questions from the group. The sector has been corresponding with you frequently on issues related to funding. We have provided some potential questions and responses as Annex 4.
