# Background

- 1. The Ngārimu VC and 28th (Māori) Battalion Memorial Scholarship Fund Board (the Board) was established in 1945 for the purpose of granting assistance for the education of any Māori, or for the purpose of promoting the study and encouraging the maintenance of the Māori language and of Māori history, tradition, and culture.
- 2. The Board usually meets three times per year in March/April, August and November. This year the last Board meeting of the year will take place on 13 October 2021
- 3. The Board meeting is from 9.00am-10.15am in the staff room at Te Kura Kaupapa Māori O te Waiū O Ngāti Porou. Your hard copy of the meeting pack is enclosed to this report and electronic and hard copies have been issued to all Board Members following approval to do so from your office.
- 4. All Board members arrive in Gisborne the night before and are staying at the Emerald Hotel. Board members are being driven to Ruatoria by Ministry staff on the 2<sup>nd</sup> July departing at 6.55am.
- 5. Following the Board meeting, members will move to Uepohatu for the launch of the Ngarimu VC and 28th (Māori) Battalion Learning Resource. A run sheet for this event is included in the General Business Section of the Board papers.

# Summary of key discussions

14. The remainder of this briefing summarises key recommendations associated with each paper

## **Financial Report**

- 15. This paper provides financial information for the Fund for the period from 1 March 2021 to 31 May 2021. The paper recommends that the Board
  - a) **Note** the forecast results for the financial year ending 30 June 2021 shows a surplus of \$38,142.

b) **Note** scholarship payments totalling \$65,000 were paid in March and April. Ten recipients met the criteria for the 2021 Milestone 1 and were paid a total of \$45,000. The Manakura Award of \$20,000 was also paid in this period. Refer Table in Annex 1.

## **Funding the VET Scholarships**

- 16. The Board has requested further advice from the Financial Standing Committee to investigate options to fund Vocational Education and Training (VET) beyond 2022 year. The paper recommends that the Board:
  - a) Agree to direct the Ministry to maintain and/or reduce the funding of current academic scholarships as below, noting that collectively this would save \$27,000

Option A: Maintain the three \$10,000 per annum for undergraduate scholarship, but reduce term from five to three years

Option B: Reduce the two master's scholarships from \$15,000 per annum for two years to \$10,000 per annum for two years

Option C: Reduce the one Doctoral Scholarship from \$25,000 per annum for two years to \$20,000 per annum for two years

## Use of Māori Battalion Taonga

20. This paper responds to the request to investigate the Board's role as the successor of the 28<sup>th</sup> Māori Battalion (NZ) Association Incorporated (**Association**) and also seeks approval to 'B Company 28<sup>th</sup> (Māori) Battalion Taonga Kaitiaki Trust' to use the words "28<sup>th</sup> NZ (Māori) Battalion" and/or "28<sup>th</sup> (Māori) Battalion" in the title of its name, the contents of its Trust Deed, and in carrying out its' activities. The paper recommends the Board:

a) Note that the Board became the "successor" of the Association for the purposes of giving (or withholding) authorisation to the use of any emblem, words, name, title, style, or designation relating to the 28<sup>th</sup> Māori Battalion, in accordance with section 18A(3)(b)(iii) of the Flags, Emblems and Names Protection Act 1981.

b) Note that the Secretariat previously provided advice that the Board becoming the successor of the Association for the purposes of the Flags, Emblems and Names Protection Act 1981 required a relatively minor amendment to the Board's governing legislation to clarify that this is in scope of the Board's functions.

  - a. That the use of the words "28th NZ (Māori) Battalion" and/or "28th (Māori) Battalion" in any of the Trust activities does not bring the name into disrepute
  - b. That any business or trade use of those words requires further consultation and authorisation by the Board.

#### Why is this resource being developed now?

From 2022 onwards, Aotearoa New Zealand's histories will be taught in all schools and kura.

The draft curriculum content embraces the histories of all the people who live in Aotearoa New Zealand and encourages schools and kura to develop local curriculum and marau ā-kura that reflect the histories of their communities.

Learning Aotearoa New Zealand's histories will help ākonga understand there are multiple perspectives on historical and contemporary events and help them develop their critical thinking and inquiry skills.

This learning resource is an example of Aotearoa New Zealand's histories in action, a marau ā-kura that reflects the history of this community.

# How does this resource support better outcomes for learners?

We know that our young people need to stay in school for as long as possible. The Ministry has a role in supporting children to want to stay in school through developing meaningful resources that engage their minds and everything that encompasses the learners.

A localised learning and teaching resource like this is a way to engage Māori learners in education. This in turn has positive effects for striving for excellent outcomes and for Māori achieving educational success as Māori.

#### What is the purpose of this resource?

The purpose of the resource is to provide an inclusive and engaging learning experience that is easily accessible for tamariki and whanau. This has been done through grounding the learning resource in the history and whakapapa of the 28<sup>th</sup> (Māori) Battalion.

## Who is this resource for?

There are two parts to this learning resource – a learning resource and a teaching resource. Communities are at the heart of localised curriculum learning and teaching resources. These resources start with whānau, mana whenua, hapū, iwi, waka, Māori.

#### Can any school across Aotearoa use this resource?

This learning resource has been developed by the Ngarimu VC and 28<sup>th</sup> (Māori) Battalion Scholarship board for tamariki of all ages, whānau, kura and schools.
