#### Background

- You have agreed to attend and speak at The New Zealand Principals' Federation (NZPF) MOOT Conference on 10 June 2022 in Wellington.
- Minister Hipkins and Associate Minister Kelvin Davis are unavailable to attend this event. In Minister Hipkins' RSVP response declining the invitation, he indicated Minister Tinetti would be happy to speak in his place.
- The conference is held at The Lambton Room, The Intercontinental Wellington, 2 Grey Street Wellington.
- 4. The theme of the conference is 'My Voice, Your Voice, Our Voice What success in Education looks like going forward'. It seeks to explore ways in which we can work together to create a stronger, more equitable education system for all. The conference usually features a range of different speakers, and breakout sessions.
- 5. You have been asked to speak following:
  - Dr Cherie Taylor-Patel, National President of NZPF who is scheduled to open the Moot at 9:10am;
  - Te Akatea President, Bruce Jepsen, who will speak at 9:30am; and
  - Fa'atili Iosua Esera, of the New Zealand Pasifika Principals' Association, at 9:45am.
- Minister Tinetti's speech slot is scheduled to begin at 10am. Minister Sio's speech will
  follow next. You are invited to stay for the remainder of the day. A programme is
  attached as Annex One.
- 7. NZPF has asked for you to share your vision for curriculum change and plans to ensure the profession has the leadership and support necessary to address achievement challenges – including what you believe are the main topics within education at the moment and for the future.
- Additional time will likely be incorporated in the programme (up to 20 minutes) for Ministers to take questions. Reactive Questions and Answers (Q&A) are attached in this briefing note as Annex Two.
- 9. Final speeches will be provided to your Offices by Wednesday 5pm 8 June 2022.
- 10. NZPF will host their annual conference on 14 16 September 2022 in Christchurch. The June Moot event differs from their conference in that it tends to support more critical discussion, with the conference focusing on development and sharing of expertise.

#### NZPF and areas of interests

- 11. NZPF recently elected Dr Cherie Patel as their President in January 2022. Dr Patel has extensive experience as a school principal, most recently as Principal of Flanshaw Road School in West Auckland. She also co-founded the West Auckland Principals' Association (WAPA) in 2008 to improve outcomes across West Auckland schools.
- 12. A range of topics may be raised by NZPF members in the Q&A, including equity index funding, planning and reporting, and progress on leadership or board focused initiatives from the Tomorrows Schools review. We have considered reactive Q&A inclusive of these topics, see **Annex Two**.
- 13. NZPF media releases, newsletters, submissions, and correspondence with the Ministry or Ministers have focused on a range of issues such as Covid, support for principals in managing challenging ākonga, and learning support.

# Tomorrow's Schools Taskforce and Leadership Advisors

14. In their submission to the Tomorrow's Schools Taskforce<sup>1</sup> in 2019, the NZPF supported the Taskforce's aspirations in the proposed report but noted caution in expecting the education system alone to achieve the objectives as education inequities are affected by society wide complexities. The NZPF supported the establishment of the Leadership Centre and considered the Tomorrow's Schools recommended leadership advisor roles as being complementary to the services NZPF provide to Principals. They were concerned that the number of leadership advisors needed to be sufficient to ensure they could undertake their duties, including a potential role in supporting principal appraisals.

### Tomorrows Schools progress

- 15. Budget 2022 funding will establish new leadership advisor roles based in the regions (Te Tai Rare, Te Tai Whenua and Te Tai Runga), to support school/kura leaders. The nature of these frontline advisory roles will be determined in collaboration with the sector and there will be some flexibility in how they operate across the different regions and in different settings, for example Kaupapa Māori.
- 16. Budget 2022 provides funding of \$22.3 million OPEX and \$0.425 million CAPEX to cover 21 leadership advisor roles, 3 administrative support roles, and 1 management role.
- 17. In combination with previous funding, there is now an investment of \$46.586 million OPEX and \$0.833 million CAPEX which is now enough for 45 Leadership Advisor roles, 3 administrative support roles, and 1 management role.
- 18. Some aspects of the Tomorrow's Schools changes (such as the development of a Code of Conduct for school boards and the establishment of dispute resolution panels) have needed to be progressed more slowly than originally planned, due to concerns about the sector's capacity to respond and adapt to further change particularly during Covid lockdowns and due to funding priorities.

# Inclusive schooling support and Highest Needs Review

- 19. NZPF submitted in March 2022 in support of the Highest Needs Review, <sup>2</sup> with concerns
  - continuity of learning supports
  - workforce capability in learning support
  - administrative burdens in learning support applications
  - resourcing of ORS
  - bridging silos in education
  - removing enrolment barriers and supporting parental choice in their children's
- 20. More recently, a NZPF media release highlighted sector concern about the practicality of schools being able to accommodate every child's learning and advocated for improved funding of learning supports.
- 21. In May 2022 Dr Patel raised concern on News Talk ZB with the lack of available support for autistic akonga following a stand-down or suspension – as well as the cap for ORS funding being too low for the level of need. This is in light of a cohort study finding that children with autism were three times more likely to be stood down or suspended than

## Highest Needs Review progress

- 22. Information gathering phases of the Review have been completed and analysis of stakeholder voice is in process. The Ministry is seeking to establish processes with other agencies as we work to develop options and opportunities for change. The Review will provide a Cabinet paper for Minister Tinetti with recommendations in October 2022.
- 23. Objectives for the Review include the development of a strategic and planned system response, which will include aligning cross agency work so it is better connected and coordinated to ensure ākonga and their whanau have access to broader government

## International students under year 9

- 24. Some principals strongly opposed the proposal to stop enrolments of international
- 25. However, NZPF was supportive of the proposal, as they consider schools should rely on government funding rather than international students to fund additional services.
- 26. Following consultation, the Ministry announced it will continue allowing international

### Covid measures in schools

27. Dr Patel recently spoke to Radio NZ asking for improved ventilation in schools for 2023. She acknowledged some principals are okay with localised decision making for mask use in school, however, other principals want stronger guidance from the Ministry of Health on

## Progress with Orange Level Settings

- 28. Under Orange Level Settings, face masks are strongly encouraged in schools, but are not required, when inside at school. They are required for children aged 12 and over on school
- 29. Schools make decisions based on their own risk assessment and context and can include health measures in their school policies that are additional to the public health order requirements. Other health measures include ventilation, good hand hygiene, cough and sneeze etiquette, and staying home when sick.
- 30. The Ministry has a programme of work in place to ensure that CO2 monitors and portable air cleaners are made available to state and state integrated schools. As of the end of May 2022, the Ministry has provided over 5000 CO₂ monitors to 2,457 schools with arrangements in place for other education providers to purchase direct at our discounted pricing. In addition, almost 6000 portable air cleaners have been provided to 2278 schools, with 12,500 units procured for distribution to schools.
