Education (School Boards) Amendment Regulations 2022 – promotion of healthy food and nutrition and reporting on individual student performance

Proposal

This paper seeks authorisation to submit the Education (School Boards) Amendment Regulations 2022 ('the Regulations') to the Executive Council. The Regulations amend the Education (School Boards) Regulations 2020 to impose duties on school boards to promote healthy food and nutrition, and to report to students and parents on the progress and achievement of individual students.

Policy

- From 1 January 2023, the National Administration Guidelines (NAGs) for school boards will cease to have effect as new provisions in the Education and Training Act 2020 ('the Act') for schools' strategic planning and reporting come into force. These include NAG 5(b), which requires schools to promote healthy food and nutrition for all students, and NAG 2(c), which specifies requirements for schools to report on student progress and achievement.
- On 29 August 2022, Cabinet agreed to replicate the NAG 5(b) requirements regarding the promotion of healthy food and nutrition, in regulations made under section 638 of the Act. Cabinet also agreed to replicate the NAG 2(c) requirement regarding student reporting in regulations made under section 639 [CAB-22-MIN-0336 refers].
- 4 Retaining these NAG requirements through regulations will ensure the continuation of obligations on school boards to promote healthy food and nutrition, and to report to individual students and their parents on the progress and achievements of the students in the same detail and frequency as they currently do.
- Cabinet's decisions will be given effect through amendments to the existing Education (School Boards) Regulations 2020, rather than by creating new sets of regulations. Amending existing Regulations will simplify and minimise the number of Regulations for schools to keep track of, and for the Ministry of Education to administer.

The Education (School Boards) Regulations 2020 have been made under section 638 of the Act, and currently include the powers and procedures of boards, but can be broadened to impose duties on school boards, as specified in section 638 2(b). In addition, section 639 (1)(c) allows regulations to be made for the purpose of monitoring and reporting on the progress of a school's students.

Promotion of Healthy Food and Nutrition

7 The Regulations will replicate NAG 5(b) to require boards to promote healthy food and nutrition for all students.

Reporting on Student Progress

- The Regulations will specify that school boards, together with the school principal and teaching staff must use good quality assessment or aromatawai information¹, report to students and their parents on the progress and achievement of individual students. The reports must be:
 - 8.1 written in plain language;
 - 8.2 address the relevant foundation curriculum policy statements and national curriculum statements made under section 90 of the Act 2020, including in mathematics and literacy, or te reo matatini and pāngarau; and
 - 8.3 be provided at least twice a year.
- 9 Under authority delegated to me by Cabinet [CAB-22-MIN-0336 refers] I have agreed to include in the Regulations the following two minor and technical changes in respect of student reporting, that arose during the drafting process:
 - 9.1 The terms New Zealand Curriculum and Te Marautanga o Aotearoa used in NAG 2(c) have been replaced with 'foundation curriculum policy statements and national curriculum statements made under section 90 of the Act 2020.' This change future-proofs the Regulations and accounts for circumstances where additional national curricula may be issued or there are name changes.
 - 9.2 The words "or aromatawai" have been added to the main wording after "good quality assessment", and to the definition of "good quality assessment information". This is needed to reflect Māori medium practices and te ao Māori.

Timing and 28-day rule

10 It is intended that the Regulations come into force on 1 January 2023 to align with when the NAGs cease to have effect. Subject to Cabinet's approval, I

recommend that the Regulations be submitted to the Executive Council on 14 November.

Compliance

- 11 The Regulations comply with the following:
 - 11.1 the principles of the Treaty of Waitangi;
 - 11.2 the rights and freedoms contained in the New Zealand Bill of Rights Act 1990 or the Human Rights Act 1993;
 - 11.3 the principles and guidelines set out in the Privacy Act 2020;
 - 11.4 relevant international standards and obligations;
 - 11.5 the Legislation Guidelines (2021 edition), which are maintained by the Legislation Design and Advisory Committee.
- The Government consulted on a proposed duty on schools to provide only healthy drinks, in addition to replacing NAG 5(b), in regulations during April to June 2022.
- The proposal to create regulations to replace NAG 2(c) was not consulted on given the Regulations would not alter the existing student reporting requirements on school boards.

Regulations Review Committee

14 There are no grounds identified under Standing Order 327 where the Regulations Review Committee could draw these regulations to the special attention of the House.

Certification by Parliamentary Counsel

15 The Regulations have been certified by the Parliamentary Counsel Office as being in order for submission to Cabinet.

Impact Analysis

These proposals did not require a Regulatory Impact Statement, on the grounds that they have no or only minor impacts on businesses, individuals, and not-for-profit entities.

Publicity

Once the Regulations are notified in the Gazette, the Ministry of Education will advise schools via the School Bulletin – an online publication sent to all school leaders and published on the Ministry of Education website.

Proactive release

18 I intend to proactively release this Cabinet paper once Cabinet decisions have been made, and subject to redaction as appropriate under the Official Information Act 1982.

Consultation

The Treasury, Department of Prime Minister and Cabinet, Public Service Commission, Te Puni Kōkiri, Ministry for Pacific Peoples, Ministry for Women, Ministry of Business, Innovation and Employment, Ministry of Social Development, Office for Disability Issues – Whaikaha, Ministry of Disabled People, Ministry of Health, Ministry of Justice, Oranga Tamariki, Ministry for Ethnic Communities, Education Review Office, and the New Zealand Qualifications Authority have been consulted.

Recommendations

- 20 We recommend that Cabinet Legislation Committee:
 - note that on 29 August 2022 Cabinet agreed to create new regulations under sections 638 and 639 of the Education and Training Act 2020 that replicate the National Administration Guidelines (NAG) 2(c) and 5(b) [CAB-22-MIN-0336 refers];
 - 2 **note** that the Education (School Boards) Amendment Regulations 2022 will give effect to the decisions referred to in recommendation 1 above;
 - 3 note that as per my delegated authority [CAB-22-MIN-0336 refers], I have included two minor and technical changes that arose during the drafting process, and that are consistent with the intent of the proposals;
 - 4 **authorise** the submission to the Executive Council of the Education (School Boards) Amendment Regulations 2022; and
 - 5 **note** that the Education (School Boards) Amendment Regulations 2022 will come into force on 1 January 2023.

Regulations

1 Title

These regulations are the Education (School Board) Amendment Regulations 2022.

2 Commencement

These regulations come into force on 1 January 2023.

3 Principal regulations

These regulations amend the Education (School Boards) Regulations 2020.

4 Enacting statement amended

In the enacting statement, replace "section 638" with "sections 638 and 639".

5 New regulations 20 and 21 and cross-headings inserted

After regulation 19, insert:

Promotion of healthy food and nutrition

20 Duty to promote healthy food and nutrition

The board of a school must promote healthy food and nutrition for all of the school's students.

Reporting on progress and achievement of students

21 Duty to report on progress and achievement of students

- (1) The board of a school, together with the school's principal and teaching staff, must use good quality assessment or aromatawai information to report to each student at the school and their parents on the student's progress and achievement.
- (2) The reports must—
 - (a) be written in plain language; and
 - (b) include the student's progress and achievement—
 - (i) across any relevant foundation curriculum policy statements and national curriculum statements made under section 90 of the Act; and
 - (ii) in literacy and mathematics or te reo matatini and pāngarau; and
 - (c) be provided at least twice per year.
- (3) In this regulation, **good quality**, in relation to assessment or aromatawai information, means that the information draws on a range of evidence to evaluate the progress and achievement of each student and build a comprehensive picture of that student's learning.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 January 2023, amend the Education (School Boards) Regulations 2020 (the **principal regulations**).

Regulation 4 amends the enacting statement of the principal regulations by adding a reference to an additional provision of the Education and Training Act 2020 (the **Act**) that authorises the making of regulations under the Act.

Regulation 5 inserts new regulations 20 and 21 into the principal regulations. New regulation 20 provides that there is a duty on school boards to promote healthy food and nutrition. New regulation 21 requires school boards, together with principals and teachers, to provide reports to students and their parents on each student's progress and achievements at the school. Both of these new regulations carry over requirements currently in the national administration guidelines (made under the now repealed Education Act 1989), which will cease to have effect on 1 January 2023.
