

Funding Shakespeare Globe Centre New Zealand from the Prime Minister's Emerging Priorities Contingency

Proposal

I propose that the Social Wellbeing Committee approve a grant of \$0.165 million from the Prime Minister's Emerging Priorities Contingency to support the work of the Shakespeare Globe Centre New Zealand (SGCNZ). Matching funding will be provided by reprioritising funds from current Vote Education baselines.

Relation to government priorities

This proposal supports the Government's physical and mental wellbeing objectives for Budget 2022 and advances the outcome 'Children and young people are learning and developing,' as set forth in the Government's Child and Youth Wellbeing Strategy.

Background

- 3 SGCNZ is an organisation which provides inclusive educational opportunities in theatre and arts to thousands of New Zealand children each year through regional and national festivals and programmes. The celebrated dramatic works of the English playwright William Shakespeare are used by SGCNZ as a means to promote children's learning and help them to develop key life skills.
- The work of SGCNZ, and the Sheilah Winn Shakespeare Festival in particular, gives our diverse children and young people throughout Aotearoa opportunities to be creative, participate in learning, and increase their confidence on the stage. The organisation reports that, during its thirty-one years in operation, more than 120,000 secondary school students have participated in SGCNZ festivals. For many years SGCNZ has also helped students perform, teachers study, and actors train at Shakespeare's Globe, a world-renowned theatre in London.
- 5 SGCNZ receives funding from a variety of sources to support its work. The organisation recently made an unsuccessful application for funding from the Arts Council of New Zealand Toi Aotearoa (Creative New Zealand) through the Toi Uru Kahikatea investment fund in 2023–2025.
- SGCNZ applied to Creative New Zealand for \$350,000. The figure of \$31,000 per year which has been reported in some media is not the full amount requested by SGCNZ to support them over the next three years. Under their current contract (through to December 2022), SGCNZ receive \$31,827 a year from Creative New Zealand. SGCNZ have guaranteed (transitional) funding from Creative New Zealand for \$11,935 through to June 2023.

Te Tāhuhu's communications with SGCNZ, as well as review of the original SGCNZ application for funding from Creative New Zealand, have confirmed that the total amount sought by SGCNZ is \$330,000 over three years. This figure excludes \$20,000 originally requested from Creative New Zealand to upgrade the SGCNZ website.

Proposed funding support for SGCNZ

- Last month I was pleased to announce that Te Tāhuhu has agreed to work with SGCNZ and provide some level of support to help them through their current financial difficulties, following their unsuccessful application for funding from Creative New Zealand. In recent weeks Ministry officials from Te Poutāhū (the Curriculum Centre) have met with SGCNZ representatives to begin discussing the terms, details, and conditions of this support.
- 9 SGCNZ are seeking \$0.330 million in additional funds to support them over the next three years to continue to deliver inclusive educational opportunities to children and young people and cover the shortfall resulting from their unsuccessful application for funding from Creative New Zealand. 9(2)(f)(iv)

but Te Tāhuhu has identified that spending can be reprioritised from the curriculum support baseline to fund half of this amount (\$0.165 million) 9(2)(f) level of fund(iv) is in line with other programmes provided for within the Curriculum Support appropriation.

- I propose that the Prime Minister's Emerging Priorities Contingency provide a one-off contribution of \$0.165 million toward supporting the work of SGCNZ over the next three years. The balance of the funding required would come through a reallocation from existing Vote Education baselines. SGCNZ would therefore receive a one-off payment of \$0.330 million in the form of an unconditional grant.
- 11 9(2)(g)(i)
- If additional funds are not secured, there is a risk that the reach and impact of SGCNZ's educational provision next year, particularly the Sheilah Winn Shakespeare Festival, will be adversely affected. Acting now will mean that young people around the country will not miss out on the opportunity to hone their acting skills, learn about Shakespeare, and benefit from the associated wellbeing outcomes that this creative experience provides. Confirmation of funding will also support SGCNZ while they plan for a financially sustainable future in the long term and locate alternative sources for ongoing funding.
- Ministry officials will work with SGCNZ on the specific expectations and conditions attached to any funding agreement, ensuring that funding assists the organisation to deliver inclusive educational opportunities now and in the future, and supports them while they establish a sustainable business model moving forward.

Financial Implications

- Ministry officials have signalled to SGCNZ representatives that any funding support from Te Tāhuhu will be in the form of a one-off grant and that further financial assistance should not be expected as a matter of course.
- The approach proposed is a short-term response to a situation that requires prompt action so that SGCNZ's provision is maintained in 2023. 9(2)(f)(iv)

Legislative Implications

17 There are no legislative implications arising directly from this paper.

Impact Analysis

There are no regulatory impacts or climate implications that result directly from this proposal.

Population Implications

- This proposal relates to the education portfolio and therefore directly affects children and a range of population groups, including ākonga Māori, Pacific learners, learners from diverse backgrounds, and disabled children. SGCNZ's educational provision positively impacts thousands of tamariki and rangatahi across Aotearoa New Zealand each year, and the Sheilah Winn Shakespeare Festival continues to grow in reach.
- While SGCNZ does not track demographic data, in their original application for Creative New Zealand funding (and based on testimonials and endorsements from schools, wharekura, teachers, and students sighted by Te Tāhuhu), SGCNZ reported that:
 - 20.1 Māori children and young people in schools and wharekura enjoy the opportunity to learn and flourish through engagement with Shakespeare and performing arts, and SGCNZ encourages learners to integrate te ao Māori and te reo Māori into their performances and to adapt and reinterpret Shakespeare's plays in ways meaningful to them;
 - 20.2 Students from socioeconomically disadvantaged backgrounds and disabled learners (including neurodivergent learners) have relished their involvement

- with SGCNZ and the opportunity to participate in and express themselves through performance;
- 20.3 LGBTQIA+ children and youth report SGCNZ provides opportunities for them to explore gender and identity in a safe and affirming way through performance and that this helps them to feel included, free, and accepted; and
- 20.4 Stage casting embraces the wide variety of ethnicities that make up Aotearoa and that different schools and communities adapt performances to reflect their local settings and contexts as well as the identities, languages, and cultures of their learners.

Human Rights

This proposal supports Article 29 and 31 of the United Nations Convention on the Rights of the Child. It is also consistent with human rights obligations set out in the New Zealand Bill of Rights Act 1990 and the Human Rights Act 1993.

Consultation

Treasury, the Department of the Prime Minister and Cabinet, and the Ministry for Culture and Heritage have been consulted in the preparation of this paper and their feedback has been incorporated.

Communications

I know a number of people have been concerned about the financial difficulties SGCNZ is facing and the potential impact. I am seeking your agreement to this proposal so that SGCNZ can maintain its provision in 2023 and diverse children across the country may continue to experience the benefits, particularly in terms of opportunities for learning and performing. All communications will continue to emphasise this point. They will also note that supporting tamariki and rangatahi to engage with literature and performing arts aligns well with the purpose and work of Te Poutāhū (the Curriculum Centre) within Te Tāhuhu.

Proactive Release

I intend to proactively publish this Cabinet paper on Te Tāhuhu's website following consideration by Cabinet and subject to any redactions that may be justifiable under the Official Information Act 1982.

Purpose of Report

This report seeks your approval to lodge the attached draft Cabinet paper requesting additional funds from the Prime Minister's Emerging Priorities Contingency to support the Shakespeare Globe Centre New Zealand (SGCNZ) over the next three years.

Summary

- 1. SGCNZ is an organisation which provides educational opportunities in theatre and arts to thousands of New Zealand children and young people each year.
- 2. On 18 October 2022, you announced publicly that Te Tāhuhu o te Mātauranga | the Ministry of Education (Te Tāhuhu) has agreed to work with SGCNZ and provide some level of support to help them through their current financial difficulties.
- 3. SGCNZ are seeking approximately \$0.330 million to support them over the next three years. Te Poutāhū | Curriculum Centre has identified that it can reprioritise spending from the Curriculum Support appropriation within Vote Education to fund half of the amount requested. We propose the Prime Minister's Emerging Priorities Contingency be used to fund a matching amount.
- 4. A draft Cabinet paper is attached seeking approval from Cabinet on this proposal (Annex 1). We understand that lodging with the Cabinet Office is planned for 10 November 2022, for consideration by the Social Wellbeing Committee (SWC) on 16 November and Cabinet on 21 November.

Background

- 1. SGCNZ is an organisation which provides educational opportunities in theatre and arts to thousands of New Zealand children each year. Its work gives young people throughout Aotearoa the opportunity to be creative, participate in learning, and increase their confidence on the stage.
- 2. SGCNZ receives funding from a number of public and private sources to support its festivals and programmes. The organisation recently made an unsuccessful proposal for funding from the Arts Council of New Zealand Toi Aotearoa (Creative New Zealand) through the Toi Uru Kahikatea investment programme in 2023–2025.
- 3. On 18 October 2022, you announced publicly that Te Tāhuhu o te Mātauranga | the Ministry of Education (Te Tāhuhu) has agreed to work with SGCNZ and provide some level of support to help them through their current financial difficulties. Ministry officials from Te Poutāhū | Curriculum Centre have been meeting with SGCNZ representatives in recent weeks to work through the details.
- 4. SGCNZ are seeking approximately \$0.330 million to support them over the next three years. Te Poutāhū has identified that it can reprioritise spending from the Curriculum Support appropriation within Vote Education to fund half of the amount requested (\$0.165 million). This level of funding is in line with other programmes provided for within this appropriation. We propose the Prime Minister's Emerging Priorities Contingency be used to fund a matching amount (\$0.165 million).
- 5. Accessing funds from the Emerging Priorities Contingency requires the approval of Cabinet. A draft Cabinet paper is attached seeking approval from Cabinet to this proposal (Annex 1). We understand that lodging with the Cabinet Office is planned for 10 November 2022, for consideration by the Social Wellbeing Committee (SWC) on 16 November and Cabinet on 21 November.
- 6. 9(2)(g)(i)
- 7. Taking action to provide this support to SGCNZ now will mean the organisation's provision is maintained in 2023 and that young people around the country will continue to have opportunities to hone their acting skills and learn about Shakespeare. It will also enable SGCNZ to plan for a financially sustainable future in the long term and begin to locate alternative sources for ongoing funding.
- 8. The regional and national programmes and events SGCNZ leads align with and support the refresh of *The New Zealand Curriculum*, particularly the refresh of the English learning area currently underway. There are also meaningful connections to other areas of the curriculum, such as the Arts and wellbeing.
- 9. We have provided Treasury and the Department of the Prime Minister and Cabinet with a copy of the draft Cabinet paper. We will keep you updated if they have any substantive feedback which we will take in alongside any feedback from you and from ministerial consultation.

Next Steps

- 12. We understand that your office intends to facilitate ministerial consultation of the draft Cabinet paper in tandem with your review of it. We will liaise with your office to ensure that any feedback or changes from you and your ministerial colleagues are incorporated before the final Cabinet paper is submitted to CabNet for lodging with SWC.
- 13. The indicative timeframes we are working to are:

- 14. Te Tāhuhu will keep you updated on discussions with SGCNZ, including as we finalise the terms and conditions of the funding agreement, which will reflect final Cabinet decisions and take the form of an unconditional grant. We will be signalling to SGCNZ that this is a one-off arrangement to help them through their current financial difficulties and an ongoing funding agreement should not be expected.
- 15. Our communications approach will continue to emphasise the benefits for children and young people of providing SGCNZ with some level of support to help them over the next few years, and that funding will enable the organisation to plan for a financially sustainable future in the long term. It will also reinforce that supporting tamariki and rangatahi to engage with literature and performing arts aligns well with the purpose and work of Te Poutāhū | Curriculum Centre.
