



# Briefing Note: BUDGET SECRET - Updating the Christchurch Schools Rebuild Programme

### Purpose of Report

You have requested an update on the progress of the Christchurch School Rebuild Programme (CSR), in preparation for Budget 21, and the final review that will outline the new capital needed to complete the programme.

#### Summary

- Following the Canterbury Earthquakes, the Christchurch School Rebuild Programme (CSR) was established to address earthquake damaged schools and ensure sufficient education provision in Christchurch. The programme's original business case, approved by Cabinet in 2012, set the total budget at \$1.137 billion.
- There are 115 schools in this programme, of which 58 are already complete. By early-2022, we anticipate this will increase to 76 schools or 66%. By 2023, the programme is expected to be about 95% complete. The final 5% represents more complex projects at larger secondary schools. These projects need to be staged so schools remain operational throughout construction.
- The midpoint review, completed in 2018, signalled than an additional \$206 million was required. As the programme has progressed and works have been completed the schools entering the programme in the later stages expect a comparable scope of works to schools that have been completed even though the original business case may have identified less investment.
- To address issues of scope to complete the programme the Ministry is undertaking a
  three-quarter point review, which will identify what is now needed to complete the
  remaining projects, meet the current expectations of schools as they align to the
  current scope of the programme and all works are complete or underway by 2023.

While the review is still underway, this report updates you on progress and provides an initial estimate of the outcome.



## Updating the CSR Programme Envelope

- The CSR programme was established to address earthquake damage at 115 Christchurch Schools. Since 2012, the Ministry has delivered seismic remediation at CSR schools. However, through this process we have uncovered significant, nonseismic condition issues in our building stock. This was to be expected. We know that our aging school property portfolio carries significant deferred liabilities that need to be addressed.
- 2. Where it was possible, and sensible, to address these issues, we have done so. The purpose of this approach was to leave schools with quality learning environments and minimise our future liabilities in Christchurch.
- 3. In 2018, a mid-point review was conducted. The original programme approved by Cabinet in 2012 did not adequately provide for expansionary pressures on the network, construction cost escalation, nor could it reasonably provide for the extent of upgrade works required at each school. The review identified the need to increase the programme envelope for the CSR programme by an additional \$206 million to cover, both initial project cost estimates that were to low, and estimate the known additional programme costs at the time, bringing the total project envelope to \$1.343 billion.

Reintroducing CSR schools to mainstream Ministry property programmes and funding

- 7. As part of the review we will consider how Christchurch schools are reintegrated into the Ministry business as usual property redevelopment and maintenance programme. While the schools will have had significant investment, it is important that ongoing funding is in place to ensure they remain well maintained including how to plan and fund future redevelopment work at CSR schools. The Ministry will update you on this as part of the outcomes of the programme review in the new year.
- 8. We will discuss further funding requirements for Christchurch Schools with you in preparation for Budget 22.
