- The Ministry of Education has been undertaking work to develop an overall Vote: Education package within Budget 2021. As part of this work, you have indicated your interest in progressing three Budget 21 initiatives across Vote Education to support Pacific Education [METIS 1244788 refers]:

Description	This initiative supports Pacific learners to learn in cultural and linguistic supportive environments by providing the first system-level investment in Pacific bilingual and immersion units in schools to meet persistent operating and resourcing needs, to maintain quality provision. This initiative will purchase targeted funding and support through an additional operational grant component, development of further curriculum resources and a targeted professional learning and development programme on Pacific bilingual and immersion education for teachers. This supports the sustainability of current provision of a highly valued community education pathway across 23 schools, serving approximately 1500 learners.	This initiative provides funding to purchase the design and delivery of a targeted, sustained professional learning and development (PLD) programme for teachers and leaders in early learning settings and schools with high numbers of Pacific learners to embed the principles and approach of Tapasā, a cultural competencies framework for teachers and leaders of Pacific learners.

## Annex 1: Talking Points on Pacific Education Budget priorities

## Pacific Education priorities

- My overall priority for Pacific Education in Budget 21 is to ensure that all our investment in education supports the needs of Pacific learners and families and the implementation of the Action Plan for Pacific Education in the evolving COVID-19 context. This will help us ensure Pacific wellbeing is supported. Every dollar we spend has to support Pacific learners.
- More specifically, there are some emerging priorities for Pacific learners and families in education that are not addressed in existing Education Budget commitments.
- To address these specific issues, I am proposing a package of three initiatives to:
  - support Pacific bilingual and immersion education in schools, by providing operational funding for existing bilingual and immersion units
  - ensure Pacific learners receive culturally responsive teaching, by delivering a sustained Professional Learning and Development programme that embeds Tapasā, the cultural competencies framework for leaders and teachers of Pacific learners
- I see these three initiatives as contributing significantly to Goals 1, Fou, our shared vision for Pacific Peoples in Aotearoa.

## Supporting Pacific bilingual and immersion education in schooling

- Pacific bilingual and immersion units in schools have been built from the ground up by Pacific communities and the education sector. These units provide a beneficial learning pathway to Pacific learners and families but operate with no additional funding. I don't think this is fair.
- I am proposing an initiative to provide the first operational investment into the 23 schools with existing Pacific bilingual and immersion units.
- This funding already exists for te reo Māori language provision in schools but has never been in place of Pacific bilingual and immersion provision in schools.
- This initiative will purchase targeted funding and support through an additional operational grant component, development of further curriculum resources and a targeted professional learning and development programme on Pacific bilingual and immersion education for teachers.
- This new funding would address the lack of funding in these units currently. Providing funding supports the sustainability of current provision and shows that the Government values this education pathway, which strongly embeds identity, language and culture.
- This initiative strongly aligns to Goal 1 of Lalanga Fou of Thriving Pacific Languages, Cultures and Identities, by investing in and supporting Pacific bilingual education provision to continue.

• This initiative seeks \$20,218m over four years as the minimum viable option

Deliver sustained Professional Learning and Development to embed Tapasā

- I have heard from some Pacific communities that some teachers do a great job teaching Pacific learners but some Pacific learners are still not experiencing culturally responsive teaching that supports them to succeed in education.
- Some teachers and leaders have asked for more targeted support to develop their competencies in teaching Pacific learners and embedding the Tapasā framework, the cultural competencies framework for leaders and teachers of Pacific learners.
- I am proposing to deliver a targeted, sustained professional learning and development (PLD) programme for teachers and leaders that will support them to embed the principles and approach of Tapasā. This will be for teachers and educators in both early learning services and schools.
- This will support teachers and educators to effectively teach Pacific learners and support Pacific learners to have a quality education.
- This initiative contributes to the wellbeing of Pacific learners by ensuring learners experience culturally responsive teaching and feel safe in their learning environments.
- This strongly aligns to Goals 1 and 4 of Lalanga Fou, by ensuring Pacific learners receive a quality education that reflects their identity, language and culture and that allows them to succeed as Pacific learners.
