Purpose of report

1. This paper seeks your approval of the 2020/21 Supplementary Estimates and 2021/22 Estimates of Appropriations for Vote Education and Vote Tertiary Education. The Budget documents and the Ministerial sign offs must be submitted to the Minister of Finance no later than 23 April 2021.

Background

- Attached are the final 2020/21 Supplementary Estimates and 2021/22 Estimates of Appropriations documents for Vote Education and Vote Tertiary Education. These documents reflect:
 - the COVID-19 Response and Recovery Foundation Package (wave 2) and July Package (wave 3)
 - the approved baselines from the 2021 March Baseline Update
 - subsequent adjustments approved by Joint Ministers in Vote Education (for example, Childcare for Essential Workers at Alert Level 4, METIS 1250401 refers) and in Vote Tertiary Education (Managing increased demand for tertiary education and training, METIS 124678 refers)
 - estimated actuals for 2020/21 to reflect the best estimates of the year-end outturn and the most likely outcome
 - Budget 2021 technical initiatives considered by Cabinet on 6 April
 - Budget 2021 significant initiatives considered by Cabinet on 12 April, and
 - non-financial information and performance measures.

3. We have previously provided drafts of the 2020/21 Supplementary Estimates and 2021/22 Estimates to your office for review and are now providing the proposed final versions for your approval.

Performance Measures

- 4. We have previously advised you of changes to performance measures across the two Votes for 2020/21 [METIS 1250034 refers] and 2021/22 [METIS 1250035 refers]. Minor changes were subsequently made to:
 - include additional Ministerial Servicing measures for 2021/22 as per your request
 - update performance information where necessary to support Budget decisions
 - · address any technical issues raised by our auditors and/or Treasury.

Next Steps

- 5. The Estimates and Supplementary Estimates documents are now complete and ready for publication. The documents have been reviewed for compliance against the Treasury's technical and style guidelines.
- 6. Please sign the attached Minister sign offs to the Minister of Finance and forward them to his office by 23 April 2021.
- 7. We will work with your office to provide communication material to support you on Budget day and your attendance at the Education and Workforce Select Committee's examination of the Estimates and Supplementary Estimates. This material will assist you and officials to proactively address any queries about the financial information and performance measures.

Proactive Release

- 8. We recommend that this Education Report is not released at this time because the information it contains is Budget sensitive. This is consistent with section 9(2)(f)(iv) of the Official Information Act 1982, which states that good reason for withholding official information exists if this is necessary to maintain the constitutional convention that protects the confidentiality of advice tendered by officials. The Estimates documents will be released by the Minister of Finance on Budget day (20 May 2021).
- 9. A proactive release of Budget 2021 reports will be prepared for your consideration as part of a wider communications strategy for your Budget 2021 package of initiatives.
