Budget 2021 Communications

- 1. Communications for Budget 2021 include:
 - Press Releases
 - a. We have attached six draft Press Releases in Annex 1 for you to review and provide feedback. Please note that the Secretary for Education has not yet seen these first drafts and would like to ensure that we have the right language around the Reform of Tomorrow's Schools. These are:
 - i. Overarching announcement for Education Building a stronger, fairer education system
 - ii. Moving towards pay parity in early learning
 - iii. School property (also included in overarching) additional background to this press release is contained below and in annex one
 - iv. Essential property maintenance at state-integrated schools (requesting approval as a pre-announcement)
 - v. Investing in vocational training
 - vi. Investing in tertiary education.
 - Budget 2021 Vote Education and Vote Tertiary Education Book
 - a. We have attached a draft Budget Book in Annex 2 for your information. This material is still being finalised.
 - b. Once finalised, the Budget Book will be a resource for your Office as well as Ministry of Education and Agency officials.
 - Budget Day 'lock-up' at Mātauranga House
 - a. Treasury have advised there will be a social sector lock-up at the Ministry of Social Development that education officials, stakeholders and media are likely to be invited to.
 - b. If you want a separate education sector lock-up your office will need to seek approval from the Minister of Finance's Office.

School infrastructure

- 2. Cabinet has agreed to (2)(j) million (CapEx) and (2)(j) million (OpEx) for school infrastructure investment through Budget 2021.
- 3. We are preparing to support you to announce \$631.4 million (CapEx) and \$50 million (OpEx) on Budget Day. These figures are rounded for announcement purposes. This funding includes:
 - a. Funding the Next Phase of the National Education Growth Plan
 - b. Property Funding to build and expand schools delivering Māori Medium Education
 - c. Purchasing Land for New Schools
 - d. Meeting Cost Increases in Legacy Redevelopment Projects
 - e. Christchurch Schools Rebuild Programme
 - f. Improving the Property at Sate Integrated Schools (OpEx only)
- 4. Table One in appendix 1 provides a reconciliation of proposed announcements. Funding for some Budget 2021 initiatives has not been included in the Budget Day announcement schedule
- 5. We have prepared two draft press releases to be released on Budget Day. The first will provide a high-level summary of the school infrastructure investment package, and the second will announce the one-off state integrated school funding package.
- 6. Further information about school infrastructure is attached in appendix 1.

Timeline of Next Steps

- 7. We would like your feedback on Press Releases (PRs) by **Tuesday 27 April**, so that we can have these fact checked by the Subject Matter Experts before the first draft of Press Releases are sent back to the Minister of Finance's Office by Friday 30 April.
- 8. The following Budget Press Release timeline was issued from the Minister of Finance's Office:

- We have not included OpEx (with the exception of state integrated school funding) in Budget Day announcements on infrastructure, though the OpEX numbers do count towards the overall \$2 billion number in the high level press release.
- Of the OpEX funding, \$277.500 million has been allocated to Holiday's Act Remediation. At this time, that funding is still a holding allocation as the Ministry's Payroll team continue to progress the remediation.



 The remaining OpEx largely relates to depreciation and capital charge associated with other initiatives. As this does not represent funding directly to schools, we have not included it in announcements.

Managing expectations when allocating further investment to existing projects

- Several initiatives allocate funding to existing projects, such as topping up Māori Medium Property Entitlement projects and funding legacy redevelopment projects to be 'shovel ready'.
- It is important that we manage school expectations regarding projects, scope and funding, which will involve a more nuanced approach than a single Budget press release.
- Instead, specific details, including school names and individual budgets can be announced in the weeks and months following Budget Day. In the past, we have supported a roadshow series of announcements across New Zealand. We will work with your office to coordinate announcements, whether through a similar roadshow or a series of press releases on the Beehive website.
- When announcing funding for the Christchurch School Rebuild Programme, it is important to note that B21 funding represents BAU investment, and is not additional to the existing programme envelope.
