Background

- 1. We consulted on the final policy proposals for network management from 14 April to 2 June 2022. As advised in June, the proposals were well supported by the sector [METIS 1289566 refers].
- 2. On 29 July 2022 Cabinet agreed to the policy for new regulations for network management [CAB-22-MIN-0281 refers].

Cabinet Legislation Committee

- 3. The attached Cabinet paper seeks approval of the Education (Early Childhood Services Network Approval) Regulations 2022. The regulations would come into effect on 1 February 2023 when the relevant provisions in the Education and Training Act commence.
- 4. We have provided you with a near final version of the regulations which we are currently finalising with Parliamentary Counsel Office. We will provide you with an updated copy prior to lodging of the Cabinet paper.

Next steps

5. We propose to follow the timeline as set out below. We will send you a revised Cabinet paper on 21 September 2022 for lodgement on 22 September 2022. We intend to have the regulations published in October to give the sector as much advance notice and certainty as possible of these new regulations before they come into effect as part of network management on 1 February 2023.
