Tēnā koe

Thank you for your email of 5 October 2022 to the Ministry of Education requesting the following information:

a list of the amount of Government subsidies given to daycare operators/companies.

I would like this organised for the top 20 subsidy amounts given to individual companies, including the amount and the name of the operator.

When I say daycare companies, where there's one umbrella owner, I mean all subsidies for that operator - eg. Best Start as a whole, all of Evolve Education, Provincial - Busy Bees and Kindercare (who I believe are the biggest four players in NZ childcare.) Can you also state how many centres each company runs/forms part of that total subsidy amount, and children if this is known.

I would like this for 2021 and so far this year, and if it's possible to get 2019 and 2020 as well.

In response to your request, we have provided the attached **Appendix A**, which gives a breakdown of 2019, 2020 and 2021 subsidies provided to service providers. For the purpose of this request, we have interpreted 'subsidy' to mean the ECE operational funding paid to licensed early learning services. The tables attached include the following payments: ECE Subsidy, 20 Hours ECE, Equity Funding, Targeted Funding for Disadvantage, Annual Top-up for Isolated Services (ATIS) funding and payments made to early learning services as part of the response to COVID-19.

We are currently finalising the payment information for 2022. We will endeavour to provide this to you as soon as possible, and in any case, will provide you with an update on or before **15 December 2022.**

The 2022 information will include all payments made during the March 2022 and July 2022 funding rounds. Information for the November 2022 funding round will only include payments made on 1 November 2022 and 21 November 2022. These initial payments represent the majority of funding paid during the November funding round. However, this information will not include payments processed in our December 2022, January 2023, and February 2023 funding rounds.

We are unable to state how many children are covered in the subsidy amounts paid. This is because ECE Operational Funding is claimed by the service for all children attending, and the individual claim generated by a child cannot be easily separated out. I am therefore refusing this part of your request under section 18(g) of the Act, as the information requested

is not held, and we have no grounds for believing that it is either held by, or more closely related to the functions of, another department or organisation subject to the Act.

Please note, the Ministry now proactively publishes official information responses on our website. As such, we may publish this response on our website after five working days. Your name and contact details will be removed.

Payment Amount

This represents the amount of funding paid to a service provider for funding rounds that occurred in that calendar year. For example, the 2021 year represents payments made as part of the March 2021, July 2021 and November 2021 funding rounds.

Funding captured in this amount includes the ECE Subsidy, 20 Hours ECE, Equity Funding, Targeted Funding for Disadvantage, Annual Top-up for Isolated Services (ATIS) funding and payments made to early learning services as part of the response to COVID-19.

Count of Services

This represents the number of services under a service provider who had funding processed for at least one funding round during that calendar year.
