Thank you for your email of 15 November 2022 to the Ministry of Education requesting the following information:

- How many pupils were disciplined (suspended, excluded, expelled etc) in 2022 in Otago and Southland?
- Please break this down into what offences pupils were disciplined for across the regions as well, such as drugs, vaping, violence etc. Please break this down per region.

Your request has been considered under the Official Information Act 1982 (the Act).

A **stand-down** is the removal of a student for a period of up to five days in a school term, where the decision is made by the principal. A student may only be stood down for a total of 10 school days in a year.

A **suspension** is the formal removal of a student from a state or state-integrated school on a temporary basis, until the school board of trustees (the board) decides the outcome at a suspension meeting. The board can either:

- lift the suspension (with or without conditions),
- · extend the suspension,
- · exclude the student (if under 16), or
- expel the student (if aged 16 years or over).

**Exclusions and expulsions** are subsets of suspension where an enrolment is terminated. If the student is aged under 16, the board may decide to exclude the student from the school, with the requirement that the student enrols elsewhere.

It is important to note that stand downs, suspensions, exclusions, and expulsions are measures of a school's reaction to student behaviour. While one school may opt to suspend a student over a particular incident, another school may not. The number of these incidents should therefore not be used as a proxy measure for total student behaviour.

The requested data is set out below.

Table 1 shows the number of students who were <u>stood down</u> in Otago and Southland regions for 2021 and 2022 up to 23 November broken down by Behaviour.

Exclusions and expulsions are subsets of suspensions and should not be added to suspensions.

## \* Caveats:

- The data is live and therefore subject to change. It was extracted 11.15am, 23<sup>d</sup> November 2022 and includes incidences recorded up to this date.
- It is important to note that suspensions, exclusions, and expulsions are not measures of student behaviour but measures of a school's reaction to such behaviours. What one school may choose to suspend for, another may not. The number of these events should not be used as a proxy measure for total student behaviour.
- Privacy rules for incident counts less than 5 have been applied under section 9(2)(a) of the Act, to protect the privacy of individuals concerned. An "x" denotes a masked cell. On the same note, totals have been concealed.
- Students suspended more than once during a year for different behaviours have been counted once in each behaviour type, they were suspended for that year. Students suspended more than once in a year for the same behaviour are only counted in that behaviour type once for that year. Students are only counted once in "Total number of students" suspended in each year. Behaviour types should not be summed as this could lead to double counting of students suspended in a year.
  e.g., a student suspended twice in a year for 'weapons' will only be counted once in this category and once in the total for that year. A student suspended twice in a year for 'weapons'
- and 'Alcohol' will be counted in each of these categories and once in the total for that year.
  "Other" category includes sexual harassment, sexual misconduct, weapons, and other harmful or dangerous behaviour.
