- Added a bit in about 400 still allowing the school to be viable educationally.

Hi Coralanne

Just checking in regarding the attached report from Philippa that I have been asked to peer review. My main concern is that the report recommends a build capacity of 400 students but then suggests a build capacity of 700 might also be an option, noting though that this would not address the network issues caused by this roll size and number of out of zone enrolments; and then also offers a further option for the Minister that you may also ask us for *further network considerations to be explored*- something I would have thought had already been done. I am wondering if there is a reason why we are being less than definitive about what is appropriate for the schooling network by offering these other options to the Minister and whether the Minister choosing a non-recommended option poses risks. My other concern is that although the rebuild or redevelopment for the build capacity of 400 is mentioned in the summary the alternative of building the school to a build capacity of 700 and the cost implications; e.g. (*annex 4: If the school is redeveloped many of the buildings retained would require extensive upgrade works to align with current Ministry design requirements and DQLS outcomes and wholesale replacement of retained buildings is not considered viable given the current budgetary constraints*) is not emphasised. Philippa has set up a meeting on Monday to discuss but if you consider that you are happy with the report and recs as it stands we do not need that meeting.

I'd also like to know where the 400 number came from. A 500 roll would be consistent with the commitment to retain the pre-quake level of intermediate school capacity would it not? Inconsistent treatment of year 7/8 students across the network when original decisions were made has left this a messy situation."
