Hostel staff COVID-19 wage subsidy application 2021

State or state-integrated schools with hostels or boarding houses can apply for the Ministry of Education's COVID-19 wage subsidy scheme.

- If you have successfully applied for an MSD wage subsidy for your hostel staff, you
 will not be eligible to also receive a Ministry of Education wage subsidy, unless you
 first repay MSD
- 2. This subsidy is to fund Board-employed staff members for the duration that their region has been affected by COVID-19 alert level three or four lockdown
- This subsidy uses the same rates as the Ministry of Social Development (MSD) subsidy
- 4. Private schools are not eligible for the subsidy from the Ministry of Education but are encouraged to apply through MSD.

Wage subsidy rates

State and state-integrated hostel staff members employed by the Board will be provided with a subsidy rate that is currently in line with the existing COVID-19 Wage Subsidy Scheme. They are:

- \$600 per week for full-time employees, where full time is 20 hours or more per week.
- \$359 per week for part-time employees, where part time is less than 20 hours per week.

Please note that the Hostel Staff Wage Subsidy is intended as a contribution only and may not cover all personnel related expenditure.

Criteria

Please confirm that you are eligible for this subsidy before applying.

The criteria to be eligible for the scheme are:

- a) The named employees are employed by the Board and work at the hostel
- b) Schools have not received any other wage subsidy for the named employees
- c) Schools have retained named employees for at least the duration of the grant
- d) Schools have paid named employees, at a minimum:
 - I. for any work at their normal rates
 - at least 80% of income where reasonably possible (for employees working reduced hours while self-isolating)
 - III. the full subsidy received for each named employee, except where a person's income is normally less than the subsidy amount, in which case they can be paid their normal salary.

To apply for the wage subsidy

- 1. Confirm that you meet the eligibility criteria.
- 2. Please fill out the following form with information related to your school hostel staff members and return it to: resourcing@education.govt.nz.

Once your application has been processed, your school will receive a letter of approval and information of the wage subsidy you will receive.

Any personal information supplied will only be used for the purpose for which it was provided or permitted by the Privacy Act 1993 or otherwise required by law. If you or your staff want to check your personal information that we hold, or request the correction of that information if required, please e-mail resourcing@education.govt.nz.
