## OIA: 1319789 - Briefings for the Incoming Ministers

Thank you for your email of 4 December 2023 to the Ministry of Education (the Ministry) requesting the following information:

- 1. Any briefing materials (any documents, ministerial advice, briefing notes, memos), that have been prepared by any Ministry of Education staff for the incoming Minister(s) of Education.
- Any additional briefing materials on the education commitments in the '100 Day Plan'.
- 3. Any additional briefing materials related to Charter Schools, Partnership Schools, or Kura Hourua.

Your request has been considered under the Official Information Act 1982 (the Act).

We have identified sixteen documents in scope of your request. The Ministry's decision on the release of these documents is noted in the below document table.

Eight documents are currently under active consideration. Your request for these documents, is refused under 9(2)(f)(iv) of the Act, to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials. We are also refusing one document under section 9(2)(j) of the Act, to enable negotiations without prejudice or disadvantage.

Some of this information has been withheld under section 9(2)(a) of the Act, to protect the privacy of natural persons. Further details regarding withholding grounds can be found on the webpage linked above.



As required under section 9(1) of the Act, we have considered the public interest in releasing the information withheld. We do not consider the public interest considerations favouring the release of this information are sufficient to outweigh the need to withhold it at this time.
