Thank you for your email of 8 October 2018 to the Ministry of Education requesting the following information:

- Copies of any communications including but not limited to Reports received by the Ministry relating to the compliance by approved transport operators (taxi companies) with provisions of the Total Mobility Service run by Auckland Transport and or providers (taxi companies) that deliver the Ministry of Education's Specialised School Transport Assistance (SESTA) programme in the Auckland region.
- 2. Copies of any emails between Auckland Transport and the Ministry relating to the compliance with the Health and Safety at Work Act by transport operators (taxi companies) who may also provide the delivery of the Specialised School Transport Assistance (SESTA) programme in the Auckland region.
- 3. Please take this request to include communications including but not limited to emails from the Ministry's School Transport Team and email address school.transport@education.govt.nz about the delivery of SESTA services by transport operators (taxi companies) from 1 January 2018 through to today's date.

Your request has been considered under the Official Information Act 1982 (the Act).

In relation to point one, I am refusing your request under section 18(e) of the Act as the requested information does not exist. I recommend you contact Auckland Transport (AT) for more information on the Total Mobility scheme.

In relation to point two, there is one email between AT and the Ministry relating to the compliance with the Health and Safety at Work Act by Transport Service Providers in scope of your request, and it is attached for your information. Contact details of Ministry and AT staff have been withheld to protect the privacy of natural persons.

I have interpreted point three as relating to SESTA providers in the Auckland region, and communications relating to the AT Total Mobility scheme contract. I am refusing this part of your request under section 18(e) of the Act as the requested information does not exist.



Hi Bruce, we have the same NZQA standards as you (I'm sure)

• <u>1748</u> - Transport passengers with impairments or disabilities

- <u>1750</u> Foster effective passenger relations
- <u>1734</u> Demonstrate knowledge of stress, health and fatigue for driving
- 3462 Demonstrate knowledge of traffic law for the purpose of safe driving
- 17593 Apply safe work practices in the workplace
- <u>26551</u> Provide first aid of life threatening conditions
- 26552 Demonstrate knowledge of common first aid conditions and how to respond to them
- 15165 Transport passengers in wheelchairs using total mobility vehicles equipped with hoist or ramp (this is only necessary for drivers who operate vans with hoists, not for all drivers)

Many of the drivers had not completed some, most or even any of them. A reasonable number had though and image assuming that many of your drivers will have done so. But might be worth checking with Murray.
