Thank you for your email of 5 December 2019 to the Ministry of Education requesting the following information:

"I request under the Official Information Act up to date information on pay-outs from the EEL to cover provider failure since the EEL was first established and right up to the most recent pay-out.

I would like:

- *Year of pay-out*
- *Provider concerned*
- *Amount of pay-out*
- *Component/amount of each pay-out that was due to:*
 - *SFP trust account shortfall*
 - *costs for re-assessment of students*
 - *costs for new courses for students where courses/quals already delivered were deemed not up to standard."*

This response has been prepared in consultation with the New Zealand Qualification Authority (NZQA).

Your request has been considered under the Official Information Act 1982 (the Act).

Under sections 238(1A) and (1B) of the Education Act 1989, the Minister of Education is empowered to use Export Education Levy funds to reimburse the Crown for expenses incurred in assisting international students affected by the closure of a private training establishment.

Please find attached as **Appendix One**, a table outlining the information you have requested.

Please note that the column "SFP trust account shortfall/reimbursement" includes all amounts paid back to students, both in cases where there were an SFP shortfall arising from mismanagement of student fees, or where the poor quality of education meant that students were entitled to receive a refund of their student fees.
