Thank you for your email of 13 May 2020 to the Ministry of Education requesting the following information further to our response to your request (OIA: 1225237 refers) relating to allocated Professional Learning and Development (PLD) hours:

• "Thanks for sending this through. Please break the information for each section down by year – apologies that this part of the initial request was unclear."

Your request has been considered under the Official Information Act 1982 (the Act).

In reference to your original request OIA: 1225237, please find below updated tables of the requested information broken down by year, in the order of your original request.

This data groups hours based on the financial year in which they have been allocated to schools/kura/Kāhui Ako/clusters as opposed to when the PLD is being delivered and paid for. Hours allocated in 2016/17 may continue to be delivered through to 2017/18, for example.

The year 2016/17 is the only financial year in which the regional teams had a full yearly budget from which to allocate. This is why it is the year in which the most hours were allocated (some of the hours to be delivered in future financial years). The decrease in hours allocated after this point are partly due to some of the hours to be delivered in that year having already been allocated in the previous year and partly due to a change in behaviour from the allocation panels who generally became more inclined to allocate smaller amounts of PLD over shorter periods of time. Regardless of when the hours are allocated, they are paid for in the financial year to which the work pertains.

The year 2019/20 had the same budget but the number of hours allocated through this system is lower as only 2 rounds of allocations were able to be processed before lockdown halted the process (there are usually 4 rounds per year).
