I refer to your email of 26 July 2019 to the Ministry of Education requesting the following information:

- *A copy of the letters dated 10 May 2019 and 4th of June 2019 and all supporting information attached, sent to the Office of the Auditor General, as referred to in their letter to Kim Shannon dated 17th of July 2019.*

Your request has been considered under the Official Information Act 1982 (the Act).

We are releasing both letters to you in full. We are releasing the attachments to these letters in part with information withheld from the following sections of the Act:

- 9(2)(a) to the protect the privacy of natural persons,
- 9(2)(b)(ii) as its release would likely unreasonably prejudice the commercial position of the organisation that supplied the information,
- 9(2)(i) to enable the organisation holding the information to carry out, without prejudice or disadvantage, commercial activities, and
- 9(2)(j) to enable the organisation holding the information to carry out, without prejudice or disadvantage, negotiations.
