



# Education Report: Budget 2020, Approach and Process for COVID-19 Initiatives

## Purpose of Report

This report seeks your agreement to our pr posed approach for submission of Budget 2020 education initiatives for Corona Virus Disease 019 (COVID-19) response and recovery, which will be considered by Cabinet on 11 May 20 0.

#### Summary

- Cabinet will conside a pack ge of Budget initiatives to respond to COVID-19 on 11 May 2020, and these nitiat ves must be submitted by 24 April.
- The funding sought t support the COVID-19 response and/or recovery on 11 May must be needed as a direct consequence of COVID-19, be required outside of the normal budget cycle, and must be unable to be met from existing baselines.
- We understand that there will be an opportunity for initiatives that do not meet the criteria fo consideration on 11 May to be considered at a later date.
- We have been working with your office to develop initiatives that could be potentially onsidered on 11 May. These fall into four categories: wellbeing, digital, early learning, and tertiary.
- We will continue to work with your office to develop this package, and will provide you
  with a reports on the initiatives that have been developed in two tranches, on 9 April and
  21 April, seeking your decisions on which initiatives will be submitted for Cabinet
  consideration on 11 May.

### Background

- 1. As a consequence of measures taken to control the spread of the Corona Virus Disease 2019 (COVID-19), changes have been made to the 2020 Budget process:
  - Cabinet consideration of the Government's 2020 Budget Package has been rescheduled from 30 March to 6 April, with the package to be considered on this date being largely confined to cost pressure initiatives
  - A third Imprest Supply Act has been passed to enable the Government to meet costs associated with COVID-19
  - Section 25 of the Public Finance Act 1989 (the PFA) has been invoked, enabling
    departmental chief executives to incur emergency expenditure needed to deal with
    the COVID-19 epidemic without appropriation, for four weeks from 27 Ma ch
  - COVID-19-related Budget initiatives need to be submitted by 24 Ap il in orde to be considered by Cabinet on 11 May, and
  - an additional Supplementary Estimates Bill is planned, to enable any de isions taken
    after the start of the Budget moratorium up to 11 May 2020 (includ ng those made
    using Imprest Supply or s25 of the PFA) to be appropriated.
- 2. The Treasury has set out the criteria that will be applied CO ID-19-related initiatives, and has also provided a template that must be use to submit these. In summary, the criteria are:
  - the funding sought must be needed as a dire t consequence of COVID-19,
  - the funding must be needed outsid of the normal budget cycle to support the response and/or recovery fr m COVID 19, and
  - the cost cannot be met from within existing baselines.
- 3. Submitted initiative templetes must set out, among other things:
  - what the initiative will do
  - how the init ive elates to the COVID-19 Pandemic response and recovery
  - why funding is urgently required for the initiative
  - the consequences of not funding the initiative, and
  - wheth r there are any other options to fund the initiative.
- 4. The process for the remaining initiatives that were developed for Budget 20 (i.e. priority-align ng initiatives that are not considered on 6 April or 11 May) has not been announced. However, we understand that there is likely to be a process for these to be considered later in the year.

#### Potential COVID-19 Education Initiatives

- 5. Based on recent discussions with you and your office, we are developing initiatives in four broad categories:
  - A Wellbeing Package. This will focus on general wellbeing, mental health support, our role in family violence responses, and continuing work on reducing racism and discrimination.

  - o an online careers system.
- An Early Learning Package. This will be aimed at ensuring the continuity, via ility
  and quality of early learning provision. It will incorporate a number of the previo s
  Budget 20 initiatives, including: a new funding band for 100% qualified teachers, ay
  equity initiatives, and a new education and care quality funding rate.
- A Tertiary Package. This will include support for students with disrupted study/student support issues 9(2)(f)(iv)
   a boost for apprenticeships, 9(2)(f)(iv)
- Largely because of prior work, some initiati es are more developed than others.
  Reflecting this we will provide you with advice on otential initiatives in two tranches,
  seeking your decisions on which of them will e submitted for Cabinet consideration on
  11 May.
  - Tranche One. This tranche will contain those initiatives that are that are already well
    developed, because substantial work ad been done on them as part of the earlier
    Budget process. It will largely contain nitiatives from the Digital Package and the
    Early Learning Package, and will be provided to you on 9 April.
  - Tranche Two. This tranche will contain those initiatives that were not included in Tranche One, becaus of the additional work required to develop them. It will largely contain initiatives in th Wellbeing Package and the Tertiary Package, but will also include any outstanding digital and early learning initiatives not able to be included in Tranche One. t will be provided to you on 21 April.
- 7. A number of the i itiatives, or components of the initiatives, that are developed may be longer term multi year undertakings. Where these do not meet the criteria for approval at the 11 May meeting, we understand that they will still be able to be considered as budget initi tives at a subsequent date. We will include further advice on how developed init ativ s align with the criteria for COVID-19 funding decisions in on 11 May in our advice.

## Next Steps

- 8. Over coming days we will continue to work closely with your office to identify, scope, develop, and cost options. We will provide you with the following further advice:
  - On 9 April. A report on a first tranche of initiatives, seeking your decisions on which
    of these will be submitted for Cabinet consideration on 11 May.

- On 21 April. A report on the second tranche of remaining initiatives, seeking your decisions on which of these will be submitted for Cabinet consideration on 11 May.
- 9. We have sought clarification from the Treasury on the process for considering the remaining initiatives that were developed for Budget 20 that are not COVID-19 related and/or do not meet the criteria for Cabinet consideration on 11 May.
