## Purpose of Report

This paper seeks your agreement to begin departmental consultation on the attached draft Cabinet paper Education and Training Bill: Fifth Tranche of Policy Approvals.

### Summary

- Proposals related to the following policy areas are included in the draft tranche five Cabinet paper (attached at Annex 1):
  - Non-Tomorrow's Schools related provisions regarding giving better effect to Te Tiriti o Waitangi/ The Treaty of Waitangi;
  - b. Proposed changes to the physical restraint framework;
  - c. Licensing of early learning services;
  - d. Proposed International Education Regulations.
- The proposed changes to the physical restraint regulatory framework reflect our discussion with you at yesterday's agency meeting (METIS 1175955 refers).
- We propose that you lodge the Cabinet paper on 10 October 2019 for consideration at Cabinet Social Wellbeing Committee on 16 October 2019.

2. give the Minister of Education the ability to request further information from applicants if an application is deemed to contain insufficient information to enable a decision to be made

#### Background

## Education and Training Bill - five tranches of policy proposals

1. Cabinet papers for tranches four and 5 of policy decisions for the Education and Training Bill are due to be considered at SWC on 16 October. These two tranches are separate because Tranch 4 is the vehicle for the legislative proposals that arise from the Government's response to the Independent Taskforce's review of Tomorrow's Schools, whereas Tranch 5 proposals arise from other policy processes.

#### Licensing of early learning services

- On 16 August 2019 we provided you with advice on a more active approach to network management in early learning [Metis 1201536 refers]. You asked the Ministry to progress enabling provisions to establish a two-stage licensing framework for early learning services to ensure any new services meet the needs of the network while also ensuring the applicants do not have a history of low quality provision.
- We have developed a set of criteria for the first stage of a new licensing process for early learning services, set out in the draft Cabinet paper. The criteria relate to the network of existing services in the area that the licence application relates to, the background of the people who will be involved with the service and the applicants history in running early learning services.

#### Next steps

- 4. With your agreement, we will begin departmental consultation on the tranche five Cabinet paper, followed by providing you with a version for Ministerial consultation. We are working towards enabling you to lodge the paper on 10 October for consideration by SWC on 16 October 2019.
- This timing should ensure that Parliamentary Counsel Office has enough time to finish drafting the Bill so it is ready for introduction by late November 2019.
