



## Education Report: Agreement to proposed NELP and TES priorities and timeline

### Purpose of Report

This paper seeks your feedback on a revised draft strategy on a page for the Statement of National Education and Learning Priorities (NELP) and Tertiary Education Strategy (TES), to enable commencement of a Cabinet process to approve the final NELP and TES, before the House rises.

## Background

---

1. Following the disruption caused by COVID-19, we recommend seeking Cabinet approval on the NELP/TES soon, so that the Government's vision for the education system, and its vital role in New Zealand's economic recovery, is clearly articulated.

## Impact of COVID-19

---

2. Since then, New Zealand has been responding to the COVID-19 pandemic. We have reviewed the draft NELP/TES in the context of COVID-19 and are confident that the priorities articulated in the draft NELP/TES are still the right ones. However, we propose a plan on a page approach, to enable the document to be rapidly progressed through departmental and Ministerial processes for approval.
3. The pandemic highlighted the equity issues that exist across the education system, and has made it even more important that our system supports success for a broader range of learners. In particular, in the post-COVID economy, the education system will need to support successful transitions from education to employment, as well as supporting people to upskill and retrain. This is a strong focus of the draft NELP and TES priorities, particularly through priority 7.

## Next steps

---

4. We have attached a draft NELP/TES on a page document and draft Cabinet paper. Subject to your agreement to these documents, we will work with your office to finalise these for SWC on 1 July and Cabinet approval on 6 July. This will mean a short period of departmental and ministerial consultation from 16 June until 23 June, and lodging the paper with SWC on 25 June.
